


Background Information on the National INAD Program (NIP)


- Established in 1998 to meet the INAD needs of 6 western states
- Expanded in 1999 to include State, Tribal, University, and private aquaculture facilities throughout the entire U.S.
- NIP is a cost-reimbursable program
 - \$400/INAD/facility/year

Top 5 Reasons to Participate with the National INAD Program

5. You don't have to worry about "losing your beauty sleep over" obtaining & administering INADs – AADAP does
4. You have legal access to a variety of unapproved "AQUACULTURE" drugs
3. You have the opportunity to generate some "kick butt" data to support broad label claims
4. You don't have to submit quarterly/annual reports to "The Man" (aka FDA) – AADAP does
1. You have a chance to work with a "crack team of mad scientists" who will try to make the entire process work "as smoothly as possible"!!!!



How to Participate

- **Fill out & send in the current year sign-up form**
- **AADAP Office sends to you:**
 - Study Protocols
 - Cooperative Agreements
 - NIP Guidelines
 - Invoice
- **AADAP Office notifies FDA & drug sponsors**
- ***Read* protocol carefully and follow use requirements**



INAD Study Protocols

- Adherence to the protocol is the "Heart-and-Soul" of INAD Process
- Approved by FDA and required to receive slaughter authorization to treat animals
- Contains all pertinent information you need to know on how to obtain and use the drug correctly



Key Study Protocol Sections

- **Drug Manufacturer**
 - Source of supply
 - Storage & handling procedures
- **Entrance Criteria**
 - Test fish are listed in protocol
 - Confirmation of the pathogen/disease
- **Treatment Schedules**
 - Must follow one of the study objectives
 - Know treatment regimen
- **Disposition of Investigational Animals**
 - Withdrawal time met
 - Proper disposal of fish
