

# **MSO Shared Service Credentialing Station Deployment Plan**

The GSA Managed Services Office (MSO), as an HSPD-12 shared service provider, is preparing for deployment of its PIV credentialing centers with the goal being to provide a nation-wide infrastructure with the capability to credential all MSO customers' employees and contractors. The current GSA customer base includes 43 Federal Agencies, with approximately 520,000 end users.

It is our Goal to provide the capability to credential all MSO customers' employees and contractors and to do so we have created a very aggressive schedule for deploying the credentialing infrastructure of 200 fixed credentialing stations and 25 mobile stations to meet the October 08 goal.

## **Deployment Plan overview:**

1. **DEPLOYMENT PRIORITY:** The MSO was established to provide a shared infrastructure that would result in cost savings for participating customers. The deployment priorities are based on a model which is driven by good business decisions to deploy credentialing stations based on the demand for services. The MSO is also proceeding with the understanding that all customer agencies will be treated with equal priority and that deployments will ensure that all participating entities have the ability to meet the HSPD-12 deadlines.
2. **CREDENTIALING CENTER PRIORITY:** The MSO approach to deployment is to locate the 200 fixed core credentialing stations and the 25 Mobile Credentialing units where there is the greatest MSO customer population density. This is to allow for maximum utilization and through put for each credentialing station. As a result of the special circumstances associated with providing a shared service solution to agencies across the federal enterprise, GSA will take the following business approach to implementation:
  - The MSO customers provided their populations by geographic location and the aggregate of these numbers were ranked from most populated to least populated areas.
  - Credentialing centers will be assigned starting with the most populated geographic areas in sufficient numbers to serve the credentialing populations. For example, Washington DC is projected to receive 8 shared and 24 leased credentialing stations.
  - Of the 225 core credentialing stations, the 25 mobile stations will be moved up to 8 times to cover 200 different geographic areas starting with the most populous and working down to cover smaller populations.
  - Some personnel will need to travel to receive a PIV credential. In locations with very small populations of employees and contractors, the MSO will be unable to support the placement of a credentialing center and these individuals will need to travel to receive credentials.
  - The MSO will deploy the first 8 credentialing stations in the National Capital Region and these deployments will occur in July '07.
  - The First 8 stations will be shared and will be assigned to Agencies willing to host a credentialing center or to a MSO run Facility within the National Capital region. The MSO will provide an Enrollment Officer through the contract for the shared enrollment stations unless the hosting agency agrees to provide one.
  - The schedule calls for 50 credentialing stations per month to be deployed beginning 75 days after contract award (early 4<sup>th</sup> Q FY '07) and continue at this pace until all 225 core credentialing stations are operational. With this schedule, credentialing capacity will increase by an additional 10,000 credentials per month with full capacity being reached in 3<sup>rd</sup> Q FY 08. The infrastructure will be in place with adequate capacity to credential all MSO customers prior to the October 2008 deadline.

3. CREDENTIALING CENTER DEFINATIONS: The MSO has defined shared, leased and hosted Enrollment stations as follows:

- SHARED- Credentialing Services provided at a MSO run and staffed Credentialing Center. **Must be open to all member agencies and contractors.** The cost for this is allocated uniformly as part of the core service enrollment seat price to all members; the centers will be deployed in locations that best meet the needs of all share-holders. The current per seat cost includes 100 operators for one year. That will be revisited with the share-holders on an annual basis. For ALL SHARE HOLDERS, this is the core service and all customers contribute to this cost. The cost drivers are the operators and the space lease (could be 5 years) of the office space.
- HOSTED- A Shared Credentialing Center. **Open to all member agencies and contractors.** Credentialing equipment is shared equipment provided by MSO and as it is 'shared' it must be in an area that meets the needs of multiple agencies (an MSO determination). The space, internet, phone, furniture and possibly staffing is provided by the hosting agency at a location specified by Hosting agency. This may or may not be where an agency has existing credentialing centers and personnel to run them that they wish to keep in operation. Some of the driving forces are not duplicating efforts (space, operators, etc) and some agencies have union agreements or long standing contracts they would like to keep in place for operators as an example. The advantage is that an agency can host within their building, service their employees locally, and the equipment and maintenance costs are shared which provides an incentive. They balance that with the requirement to service anyone with MSO hours of minimum 8 hours per day, 5 days a week.
- LEASED- First, let's understand why the term LEASE is used instead of PURCHASE. We wanted to insure that the contractor would always be responsible for the equipment, be responsible for IAVA updates, and be responsible for equipment upgrades. That was best served under a LEASE option. This option allows the entire Credentialing Center Operation to be paid for and staffed by an agency. Access control, location, labor, and infrastructure provided by leasing agency. An agency chooses this option because they have many employees at a closed site, they have employees with special needs and jurisdiction, or they wish to mitigate the time lost for traveling to a shared system site. Some agencies are willing to do this for their employees as a time saver. Example: An organization may be direct charge agency that would have to pay time, travel, etc for each employee and recognize that the cost for employee travel will far exceed the purchase price and an operator (an operator that may be in their existing management structure or even a part-time employee based on the population). It may be an agency that has security concerns and does not wish to share but has a strong business case for having credentials done quickly (an IT service center where all employees are required to use cryptographic log-on).

## **Detailed deployment: Phase 1 the first 8 Credentialing Centers**

This deployment plan will be addressed in two sections; the first section, Phase 1 will constitute a plan to deploy the 8 Shared Credentialing Centers within the National Capital Region. Commencement of deployment will start 75 days after award with the first lot of 4 Credentialing Centers. The second lot of 4 will be delivered 2 weeks later for a total of 8 Credentialing Centers. These Credentialing Centers will be shared.

### **Phase 1 deployment assignments for the first 8 credentialing centers:**

75 days after award the vendor will start installing 8 credentialing centers. These credentialing centers will be deployed to hosted or MSO credential centers as follows:

Installed credentialing centers will be fully function and ready to process enrollee's by July 16, 2007. Agencies must have Roll players trained and certified prior to this Goal live date for Phase 1.

Facility assignment for hosted stations is at the discretion of the accepting agency. Each agency is responsible for providing access to the facility for the vendor to install, test and certify each credentialing center. Accepting agency is responsible for providing minimal furnishings and IT infrastructure as described in Appendix A (Deployment Ready Guide). Accepting agency will provide the MSO Team leader with final facility address, facility POC and facility telephone number at least 30days prior to acceptance of Credentialing Center. Failure to do so will result in reassignment of Credentialing Center.

## **Detailed deployment: Phase 2**

### **National Capital Region: Full implementation:**

After the 8 initial Credentialing centers have been placed, then the remaining credentialing populations within the NCR will be furnished with either leased or MSO Shared credentialing centers as requested. Those agencies who indicated that they would utilize the shared MSO run credentialing centers may start processing their employee's as soon as the MSO Shared stations are open for business. The following table indicates which agencies have requested Credentialing stations. The Number of credentials stations depicted are in addition to those already received during phase 1.
