Subject: Fiscal Year 2009 Youth Conservation Corps-Recruitment and Hiring Procedures

The following guidance will assist you in operating your Fiscal Year (FY) 2009 Youth Conservation Corp (YCC) Program. For those Refuges/Fisheries offices that had a YCC Program in FY 2008, attached is the YCC allocation that will be fund targeted to the stations organization code. Charge all associated YCC salaries and expenditures to the cost structure identified on the attachment. Since we are under a Continuing Resolution, the funding is based on the FY 2008 level, therefore the actual allocation is subject to change. You are encouraged to use any other discretionary funds for this effort, for example, other annual maintenance funding, base discretionary funding, or any other available funding.

Recruitment may begin immediately and selections should be made on or about April 15th. Enrollees will be paid minimum wage based on the area, as each State will have a different minimum wage amount.

The minimum wage increase will continue to impact your budgets again this year. The third and final phase of minimum wage increase will be completed this year. The effective date for the final increase is July 24, 2009. The new minimum wage will be \$7.25 per hour. Some states still have higher minimum wage rates than the Federal rate and the higher of the two will always be given to the YCC participants. Youth leaders will receive 15 percent higher pay than the minimum. In an effort to expedite payments to the YCC enrollees, participants are encouraged to receive their pay via direct deposit.

To facilitate personnel processing of enrollees, please forward the completed forms listed below to the Regional Personnel Office, MS 60182, Attention: Darlene Raymond, immediately after the

enrollee reports for work. All forms are available on the new YCC website located at <http://www.fws.gov/mountain%2Dprairie/ycc/>.

- ✓ Personnel Master Change Notice
- ✓ YCC Enrollee Information Sheet, which includes the 2008 IRS Form W-4
- ✓ YCC Medical History
- ✓ Employment Eligibility Verification

All enrollees are required to have a Social Security Number (SSN). There is no need to process an electronic SF-52 to bring on or terminate an enrollee. To terminate an enrollee, send an e-mail message to Darlene Raymond stating the enrollee's name, SSN, and the last day worked (make sure to encrypt the e-mail message). As a reminder, YCC enrollees cannot work beyond September 30, 2009.

YCC Work Project Plan and Job Hazard Analysis (JHA) forms are still required. The Regional Safety Office reviewed and updated eight JHA's in 2004, which most likely pertain to YCC work. If you are planning a project that is not covered by one of these JHA's, please prepare a new or submit an existing JHA. Copies of the JHA's and all other necessary forms are available on the YCC website located at <http://www.fws.gov/mountain%2Dprairie/ycc/>. Please contact Terry Black in the Safety Office, at (303) 236-8115, if you need guidance or assistance completing the JHA's.

The new YCC website contains forms and instructions for project planning, processing employees, and submitting the annual report. As you work with YCC throughout the summer, please track any other expenditure, for example, staff salaries to supervise (ABC code 5C) and other costs such as supplies purchased. Please submit the Work Accomplishment Report at the end of your program. Remember that Environmental Education is a strong component of the YCC program. This can be done while at the job site. Take advantage of teaching moments as they occur.

YCC Federal Minimum Wage Increase

The minimum wage increase will impact your budgets again this year. As outlined below, the Federal increase is taking place in three phases. Some states still have higher minimum wage rates than the Federal and the higher of the two will always be given to the YCC participants. Youth leaders will, as always, be entitled to 15% higher pay than the minimum.

<u>Phase</u>	<u>Effective Date</u>	<u>New Federal Minimum Wage</u>
One	July 24, 2007	\$5.85 per hour
Two	July 24, 2008	\$6.55 per hour
Three	July 24, 2009	\$7.25 per hour
