

ALL DIRECTIONS ARE FROM THE INTERSECTION OF VA-3 AND US-360 IN WARSAW (RICHMOND COUNTY).

Directions to FRANKLIN Tract (Richmond County):

Take US-360 West (toward Tappahannock). Refuge is 3.6 miles on the left (by Northern Neck Seafood)

Directions to HUTCHINSON Tract (Essex County):

Take US-360 West (toward Tappahannock).

Turn RIGHT onto US-17 South.

Proceed 1.5 miles. Refuge entrance is on the left. Go to the next turnaround and go back to the entrance.

Directions to LAUREL GROVE Tract (Richmond County):

Take VA-3 South

Proceed 11.8 miles, then turn RIGHT onto Rt 608/Farnham Creek Rd.

Proceed for 1.3 miles, then turn LEFT onto Rt 647/Hales Point Rd.

Proceed for 2.4 miles, then turn RIGHT onto Rt 610/Laurel Grove Rd.

Proceed for about 0.5 mile, Refuge is on the right (look for boundary signs featuring a blue goose).

Directions to MOTHERSHEAD Tract (Westmoreland County):

Take US-360 West (toward Tappahannock).

Proceed for 3.2 miles, then turn RIGHT onto Route 624/Newland Road.

Proceed 7 miles and veer LEFT at "Y" in road.

Proceed 0.4 mile to "T" and turn LEFT onto Route 625/Horners Mill Road.

Proceed approximately 4.5 miles and turn LEFT onto Route 640/Layton Landing.

Proceed 0.3 mile and turn RIGHT onto Route 637/Leedstown Road.

Proceed 3.4 miles and turn LEFT onto Route 696/Liberty Farm Road.

Refuge entrance is at end of road, at gate adjacent to Refuge sign on left side of cul de sac.

Directions to PORT ROYAL Tract (Caroline County):

Take US-360 West (toward Tappahannock).

Turn RIGHT onto US-17 North and follow to US-301 (about 25 miles).

Turn RIGHT onto US-301 North and follow to Caroline Street (about 2 miles).

Turn RIGHT onto Caroline Street and follow to end. Road ends at Refuge.

Directions to TAYLOE Tract (Richmond County):

Take US-360 West (toward Tappahannock).

Proceed for 3.2 miles, then turn RIGHT onto Route 624/Newland Road.

Proceed for about 1/3 mile, turn LEFT onto Naylor's Beach Road.

Proceed for 2 miles, Refuge entrance will be on the right.

Directions to THOMAS Tract (Essex County):

Take US-360 West (toward Tappahannock).

Turn LEFT onto US-17 South.

Turn LEFT onto Winston Road (at Race Way gas station).

Proceed to "Y" in road and veer LEFT.

Proceed to Refuge entrance gate.

Directions to TOBY'S POINT Tract (King George County):

Take VA-3 (continuing for about 3 miles past Oak Grove) to Route 627 at Rollins Fork.

Turn LEFT onto Route 627 at Rollins Fork. Continue to follow Route 627 until it ends at public boat ramp.

Refuge is to the right and left of the parking lot.

Directions to WILNA Tract (Richmond County):

Take US-360 West (toward Tappahannock).

Proceed for 3.2 miles, then turn RIGHT onto Route 624/Newland Road.

Proceed on Newland for 4.2 miles, then turn LEFT onto Strangeway/Route 636.

Proceed for 1/4 mile, then turn RIGHT onto Sandy Lane/Route 640.

Proceed for about 1 mile, then turn LEFT onto Refuge.

Directions to WRIGHT Tract (Richmond County):

Take US-360 West (toward Tappahannock).

Proceed for 3.2 miles, then turn RIGHT onto Route 624/Newland Road.

Proceed on Newland for about 5 miles, pass Sandy Lane on the left

Proceed for 1-2 more miles, turn Left onto Jones Creek Road.

Proceed for about .5 - .75 of a mile, take the first Left onto an unmarked dirt road. Dirt road ends at Refuge gate.
