



# Okefenokee National Wildlife Refuge Fee Waiver Request



Educational or scientific groups that plan to visit Okefenokee NWR (including Stephen C. Foster State Park) for educational or scientific purposes may receive a waiver of the normal entrance fees. Authority to grant this waiver is contained in the Land and Water Conservation Fund Act of 1965 (as amended and codified in 16 USC 4201-4); with implementing regulations found in 36 CFR 71 and National Wildlife Refuge policy. Groups applying for a waiver are required by these Federal statutes to comply with the following:

- a) Provide proof of educational or scientific status.
- b) Visit must relate directly to the area visited and shall not be primarily for recreational purposes.
- c) Applicant must provide a statement as to the educational or scientific purpose of the proposed visit.
