The Migratory Bird Conservation Commission

Sections 2 and 3 of the Migratory Bird Conservation Act of February 18, 1929 (Act), as amended, established the Migratory Bird Conservation Commission and provided for an annual report of the operations of the Commission.

Section 2. A Commission to be known as the Migratory Bird Conservation Commission, consisting of the Secretary of the Interior, as Chairman; the Administrator of the Environmental Protection Agency; the Secretary of Agriculture; two Members of the Senate, to be selected by the President of the Senate; and two Members of the House of Representatives, to be selected by the Speaker; is created and authorized to consider and pass upon any area of land, water, or land and water that may be recommended by the Secretary of the Interior for purchase or rental under this Act and to fix the price or prices at which such area may be purchased or rented; and no purchase or rental shall be made of any such area until it has been duly approved for purchase or rental by said Commission. Any Member of the House of Representatives who is a member of

the Commission, if reelected to the succeeding Congress, may serve on the Commission notwithstanding the expiration of a Congress. Any vacancy on the Commission shall be filled in the same manner as the original appointment. The ranking officer of the branch or department of a State to which is committed the administration of its game laws, or his authorized representative, shall be a member ex officio of said Commission for the purpose of considering and voting on all questions relating to the acquisition, under said sections, of areas in his State. For purposes of said sections, the purchase or rental of any area of land, water, or land and water includes the purchase or rental of any interest in any such area of land, water, or land and water.

Section 3. The Commission hereby created shall, through its Chairman, annually report in detail to Congress, not later than the first Monday in December, the operations of the Commission during the preceding fiscal year.

Approvals During Fiscal Year 2001

In Fiscal Year 2001, the Migratory Bird Conservation Commission approved the acquisition boundaries at three national wildlife refuges that were previously established. These three refuges, totaling 12,285 acres, are the Eastern Shore of Virginia National Wildlife Refuge in Northampton County, Virginia, previously established through the transfer of lands from the Department of the Air Force; Rappahannock River Valley National Wildlife Refuge located in Essex and Westmoreland Counties, Virginia, previously established through a donation from the Chesapeake Bay Foundation; and Steigerwald Lake National Wildlife Refuge in Clark County, Washington, established through the purchase of lands using monies from the Land and Water Conservation Fund. The Commission approved boundary additions, totaling 53,817 acres, to 11 refuges that were previously approved by the Commission. The Commission also approved the purchase price of 53,394 acres at 31 refuges and reapproved the price for one tract consisting of 315 acres.

The Migratory Bird Conservation Fund

The Migratory Bird Conservation Fund provides the Department of the Interior with monies to acquire migratory bird habitat. There are four major sources of money for the Fund. The most well-known source is the revenue received from the sale of Migratory Bird Hunting and Conservation Stamps, commonly known as Duck Stamps, as provided for under the Migratory Bird Hunting and Conservation Stamp Act of March 18, 1934, as amended. The other three major sources include appropriations authorized by the Wetlands Loan Act of October 4, 1961, as amended; import duties collected on arms and ammunition; and receipts from the sale of refuge admission permits as provided for in the Emergency Wetlands Resources Act of 1986. The Fund is further supplemented by receipts from the sale of products from refuge lands and rights-of-ways across national wildlife refuges, the disposal of refuge lands, and reverted Federal Aid funds.

Two land acquisition programs are financed from the Migratory Bird Conservation Fund. The first involves the purchase of major areas for migratory birds under the authority of the Migratory Bird Conservation Act. Lands acquired through this program are considered and approved by the

Migratory Bird Conservation Commission. The second program involves the acquisition of small natural wetlands and associated uplands located mainly in the Prairie Pothole Region of the upper Midwest. These lands, known as Waterfowl Production Areas, are acquired under the authority of the Migratory Bird Hunting and Conservation Stamp Act and do not require approval from the Commission.

During Fiscal Year 2001, the Department of the Interior obligated a total of \$23,893,651 for the acquisition of land and interests in land totaling 36,256 acres in major migratory bird conservation areas. An additional \$18,295,903 were obligated for projects in Waterfowl Production Areas totaling 87,744 acres.

A total of \$54,551,596 was available for obligation from the Migratory Bird Conservation Fund during Fiscal Year 2001. Obligations for all Migratory Bird Conservation Fund land acquisition functions during the fiscal year totaled \$52,851,889 (\$363,151 of which was prior year recoveries). Total obligations equate to 97 percent of the available funds.

New National Wildlife Refuge Boundary Approvals

In Fiscal Year 2001, the Migratory Bird Conservation Commission approved the acquisition boundaries of three national wildlife refuges that were previously established. These three refuges are: the Eastern Shore of Virginia National Wildlife Refuge, Northampton County, Virginia; the Rappahannock River Valley National Wildlife Refuge, Essex and Westmoreland Counties, Virginia; and the Steigerwald Lake National Wildlife Refuge, Clark County, Washington.

Eastern Shore of Virginia National Wildlife Refuge

Northampton County, Virginia

The Eastern Shore of Virginia National Wildlife Refuge was established on August 27, 1984, when the U.S. Fish and Wildlife Service accepted the transfer of 180 acres from the U.S. Department of the Air Force. Lands were subsequently added with assistance from The Nature Conservancy. An Environmental Assessment prepared in 1984 identified additional habitat protection that is necessary to preserve the migratory bird resource values of the area.


The refuge is located at the southern tip of the Delmarva Peninsula in Northampton County, Virginia, at the mouth of the Chesapeake Bay. It provides a critical staging area for large concentrations of waterfowl, water and shorebirds, woodcock, raptors, and passerines during their fall migration. The high density of migratory birds results from the geographic configuration of the Delmarva Peninsula which "funnels" the birds through the area during their southward migration along the Atlantic Coast.

The Commission approved the 1,431 acre refuge boundary on September 19, 2001.

**Rappahannock River Valley National
Wildlife Refuge**

*Essex and Westmoreland Counties,
Virginia*

The Rappahannock River Valley National Wildlife Refuge was previously established on May 28, 1996, with a donation from the Chesapeake Bay Foundation, to assist in meeting waterfowl population, endangered species, and wetland goals of the North American Waterfowl Management Plan, the Service's Chesapeake Bay/Susquehanna River Watershed Program, and other national and regional resource priorities. The refuge is located in Essex and Westmoreland Counties southeast of Fredericksburg, Virginia, along the Rappahannock River from Skinkers Neck to Morattico Creek.

The Rappahannock River and its adjacent marshes and waters are one of


the Chesapeake Bay's most important and productive estuarine assets, supporting a wide diversity of subaquatic and emergent wetland plant communities. These lands and waters provide optimum habitat for large concentrations of waterfowl and other migratory birds such as black ducks, mallards, blue wing and green wing teal, pintails, Canada geese, and tundra swans. The emergent wetland plant communities include important wildlife food plants such as wild rice, wild millet, bulrush, sedge, and arrowhead. Declining species breed in the marshes (least bittern), in the adjoining fields (grasshopper sparrow) and in forested areas (wood thrush). Seven heron rookeries have been identified along the River and the American bald eagles and osprey nest and feed throughout the River corridor.

The Commission approved the 9,574 acre boundary on March 14, 2001.



**Steigerwald Lake National Wildlife
Refuge**

Clark County, Washington


The Steigerwald Lake National Wildlife Refuge was established on March 27, 1986, with the purchase of 27.02 acres of land from the Trust for Public Land using Land and Water Conservation Fund dollars. The refuge is located in Clark County, Washington, 30 miles west of Vancouver along the Columbia River.

The Steigerwald Lake National Wildlife Refuge consists of semi-permanent wetlands and associated canary grass

seasonal wetlands, pasture lands, and scattered stands of cottonwood riparian habitat and Oregon white oak. Pastures have been improved to provide increasing use by wintering Canada geese, with populations increasing from roughly 500 to over 2,000. Improvements to the wetlands have created the ability to flood much of the bed of Steigerwald Lake, resulting in increasing populations of ducks, including mallards, American wigeon, pintail, and others from under 500 to more than of 5,000 birds.

The Commission approved the 1,280 acre boundary on September 19, 2001.

Notes on Tables One and Two

The information contained in this report includes those acquisitions and dispositions of land and interests therein that are purchased with Migratory Bird Conservation Fund monies or acquired under the authority of the Migratory Bird Conservation Act. It also includes other migratory bird areas such as those that are transferred to the Fish and Wildlife Service under the authority of Public Law 80-537 to carry out a migratory bird management program (these will appear on Table 1).

In an ongoing effort to improve data quality, the figures in Tables One and Two may show minor changes from previous annual reports. Lands in which the Service previously acquired a less than fee interest (leases and easements) may be purchased in fee during the year, and the number of easement or lease acres will show a decrease and the number of purchased acres an increase. The acreage appearing in the Approvals and Summary of Land Acquisitions sections of this report will not appear in Tables One or Two until after the tracts are acquired and the funds are actually expended. Also, a newly approved refuge will not appear on Table One until the tracts are acquired.

Note that the annual lease payments appear in the Cost Column 4, even though no new acres are leased (e.g., Browns Park, CO in Table 1). Also note that after the easement or lease expires or is purchased in fee and the acres no longer appear in column 7, the cumulative costs for those leases and easements will continue to appear in column 8.

A new Migratory Bird Refuge was created in Fiscal Year 2001 when the existing Black Bear Unit of the Tallahatchie National Wildlife Refuge in Mississippi was renamed the Coldwater River National Wildlife Refuge. Because the land in the Coldwater River NWR was acquired prior to Fiscal Year 2001, the acreage does not appear under the Fiscal Year 2001 MBCF Acquisitions in Table 1 but is added to the "Purchased" acres and cost columns under the Cumulative Totals.

The Lower Rio Grande National Wildlife Refuge in Texas no longer appears in Table 1 because the two tracts at that refuge that were acquired with Migratory Bird Conservation Fund monies (a total of 7,271 acres in Cameron County) were transferred to the Laguna Atascosa NWR in Fiscal Year 2001. This transfer allows for more efficient and effective administration and management of these tracts that are now located only 15 minutes from the refuge headquarters office at Laguna Atascosa NWR.

A new Assabet River NWR was established on a portion of the former Fort Devens through a transfer of administrative jurisdiction by the Department of the Army using our Pub. L. 80-537 authority. The refuge is a former Army training facility located in the towns of Sudbury, Hudson, Maynard and Stowe, Massachusetts.

By mutual agreement, the Department of the Army Corps of Engineers and the Fish and Wildlife Service terminated their Agreement providing the Service with secondary jurisdiction on lands at the Pocasse NWR in South Dakota. These lands are part of the Corps' Stewardship Program and are managed by the State of South Dakota. This overlay refuge no longer exists and has been removed from Table 1.

Pocahontas County was added to the Waterfowl Production Area Counties listed in Table 2 and is administered as part of the Iowa Wetland Management District.

North American Wetlands Conservation Fund (Summary) Fiscal Year 2001

The Migratory Bird Conservation Commission approved 98 standard wetland conservation project proposals for funding in Fiscal Year 2001 under the North American Wetlands Conservation Act. A total of \$66,679,771 from the North

American Wetlands Conservation Fund, together with \$240,819,996 in partner funds, are supporting 47 projects in the United States, 29 in Canada, and 22 in Mexico. The following tables provide summary and detailed allocation information.
