

### General Provisions

Hatchie National Wildlife Refuge is one of over 500 national wildlife refuges. The primary objective of a national wildlife refuge is to provide habitat for the conservation and protection of all species of wildlife. The harvest of surplus animals is one tool used to manage wildlife populations. Carefully managed hunts maintain wildlife populations at a level compatible with the environment, provide wholesome recreational opportunities, and permit the use of a valuable renewable resource.

The regulations listed below supplement the general regulations which govern hunting and fishing on wildlife refuge areas as set forth in Title 50, Code of Federal Regulations. Hunting and fishing will be in accordance with applicable State regulations.

### Access Regulations

Access for hunting, fishing, and other public use is permitted on the 11,556 acres of Hatchie National Wildlife Refuge, except as may be regulated by other provisions, such as special closures for sanctuaries or by signs on the area. **Public access is allowed during daylight hours only, with the exception of other legal hunting activities.**

### Roads

Roads may be closed at any time due to adverse weather conditions or management needs. While on the refuge, **vehicles must remain on established roads as designated on the map on the reverse side.**

### Vehicles

Only legally licensed vehicles are allowed on refuge roads as shown on map. **Off Road Motorized vehicles prohibited.**

### Parking

Vehicles may be parked alongside refuge roads as shown on map in a manner that will not interfere with normal flow of traffic. Use of parking lots/areas is encouraged.

### Closed Areas

Designated areas are closed to hunting, fishing, and all public access from November 15 through March 15 to provide sanctuary for waterfowl. (See map for areas closed).

### Cultural Resources

All natural, historical, and archaeological features are protected by federal law. Searching for or removing any object of antiquity including arrowheads, antlers, vines, pottery or other artifacts is **prohibited.**

### Camping/Fires

### Dogs/Pet(s)

All dogs used for hunting on refuge lands must wear a collar displaying the owner's name, address, and telephone number. All other dogs/pets must be kept under control while on refuge lands.

### General Hunting Permit

This general permit is required for all hunting on the refuge. Permit, identification, and valid TN hunting license must be shown upon request by any refuge or Tennessee Wildlife Officer. The signing on the designated line on the front of this leaflet validates it as your general hunting permit.

### Quota Deer Permit

An official U.S. postcard is required for the drawing. Official postcards will be accepted between July 1-29 and must be received by 4:00pm July 30. Mail official postcard to:

The drawing will be held on **August 1, at 9 a.m.** at the refuge office. Applicants are welcome to participate in the public drawing.

**Please type or plainly print the full name and address of each hunter. One name on the front of the postcard and up to two names on the back. Limit of three names per hunting party. Clearly state your hunt date choice (s) (i.e. 1st choice Nov 5-6 and 2nd choice Nov 12-13 or Nov 5-6 hunt only or Nov 12-13 hunt only).**

Duplicate, incomplete, nonlegible applications and/or on anything other than an official U.S. postcard will not be considered for the drawing.

Youths up to 16 years of age must list the name of the person supervising them on the postcard when applying, stating whether they are supervising only or a supervising hunter.

**Only successful applicants will be notified by mail to submit \$12.50 per hunter (Money Order or Cashiers Check only), payable to the U.S. Fish and Wildlife Service.**

### General Hunting Regulations

All hunters using shotguns for hunting on Hatchie NWR must use and possess ammunition containing approved **non-toxic shot.**

All hunting is prohibited within 100 yards of the Refuge Headquarters, the disability fishing facilities, and Oneal Lake Wildlife Drive.

Hunters may access the refuge no more than 2 hours before legal sunrise and no more than 2 hours after legal sunset.

Hunters born after 01/01/69, must possess proof that they have successfully completed a hunter education course. All hunters are encouraged to complete a hunters safety course.

Youths up to 16 years of age must be supervised by an adult 21 years old or older. An adult **may supervise only one youth under** 16 years of age, **except** two may be supervised in a hunting blind during waterfowl hunts. The adult must be in sight and normal voice contact of the youth supervised.

Treestands, temporary blinds, etc. must be removed daily! The use of nails, wire, screws, or bolts to attach a stand to a tree, or hunting from a tree into which a metal object has been driven to support a hunter is prohibited.

It is unlawful to mark any tree or other refuge feature with paint or similar substance. All flagging tape and other marking materials must be removed at the end of the hunt day.

**Only species listed in this regulations leaflet as open to hunting may be taken.**

The use of electronic or photographic trail monitoring devices is prohibited.

### Firearms

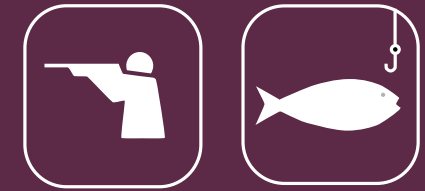
Persons possessing, transporting, or carrying firearms on National Wildlife Refuges must comply with all provisions of state and local law. Persons may only use (discharge) firearms in accordance with refuge regulations (50 CFR 27.42 and specific refuge regulations in 50 CFR Part 32).

Carrying, possessing or discharging of fireworks or explosives on national wildlife refuges is prohibited. The use or possession of air guns, spears or similar weapons on national wildlife refuges is prohibited.

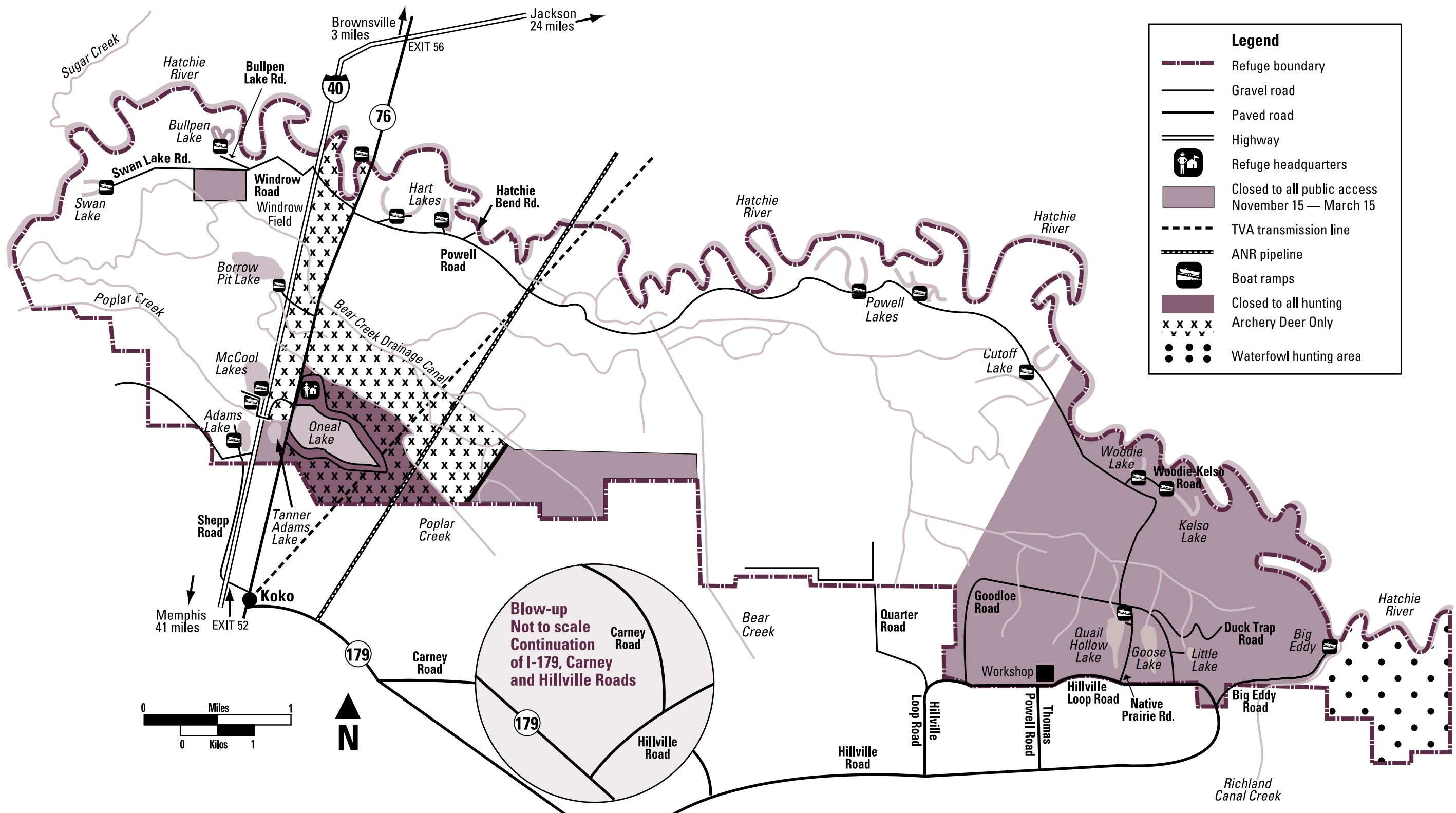
