**APPLICATION
FOR 2008 HUNT SPECIAL USE PERMIT**

To apply for the 2008 General Hunts, the \$10 application fee (payable by money order, certified check, or cashier's check **only**) per person and the application form must be COMPLETELY filled out and postmarked or dropped off at refuge headquarters by 1:00 p.m., August 18, 2008. There is no application fee required for the Youth Hunt. A public drawing will be held in September, 2008. Each successful permittee will be notified with a Notification Card as to which hunt they were drawn for. Submission of more than ONE application for any hunter shall be cause for rejection of ALL his/her applications. This application may be submitted with up to 3 other applications. Each person in a group must fill out an individual application. Group applications must indicate the same choices and be stapled together and mailed in one envelope. Group applications will either all be drawn or all left out. Only one hunt permit can be issued to each hunter. By the end of September, all applicants will be notified by letter whether or not their application was drawn. Please refer to permit fee instructions once your notification card is returned. Each applicant must sign his own application. Unsigned, incomplete, or illegible applications will be rejected. Duplication of this application is prohibited.
