

Specific Instructions Regarding Big Game Hunt Application Form (3-2356)

Follow instructions as designated in the 2009 *Hunting on Balcones Canyonlands NWR* Flyer, Big Game Hunt Application Form (3-2356), and fill out the two address sections of this form. Submit both the 3-2356 and this form. In addition to federal regulations, Texas Parks and Wildlife Department laws and regulations are in effect unless further restricted by Federal law or regulations. All general hunt permits will be issued for legal take of the following three species: Deer (antlerless bucks and spiked bucks) feral hogs, and bearded turkeys. Hunt method is as designated in the TPWD regulations.

Please note *not applicable* under number 4 and 5 of the Form 3-2356.

Number 8 and 9 are only applicable to hunters that wish to apply for a disability hunt or youth hunt. All other hunters may leave these lines blank or mark as *not applicable*.

**INSTRUCTIONS
FOR 2009 HUNT SPECIAL USE PERMIT**

To apply for the 2009 General Hunts, the \$10 application fee (payable by money order, certified check, or cashier's check **only**) per person *and* the Big Game Hunt Application Form (3-2356) must be **COMPLETELY** filled out and postmarked or dropped off at refuge headquarters by 1:00 p.m., August 17, 2009. There is no application fee required for the Youth Hunt. (For youth hunt, you must be 12-16 years old and supervised by an adult at least 21 years old). A public drawing will be held in September, 2009. Each successful permittee will be notified with a Notification Card as to which hunt they were drawn. Submission of more than **ONE** application for any hunter shall be cause for rejection of **ALL** his/her applications. The application may be submitted with up to 3 other applications. Each person in a group must fill out an individual application. Group applications must indicate the same choices and be stapled together and mailed in one envelope. Group applications will either all be drawn or all left out. Only one hunt permit can be issued to each hunter. By the end of September, successfully drawn applicants will be notified by letter. Please refer to permit fee instructions once your notification card is returned. Each applicant must sign his own application. Unsigned, incomplete, or illegible applications will be rejected.
