NWFCC 2012– Progressive Fish Culture in the Northwest

The deadline for submitting abstracts will be August 31, 2012. Preference will be given to submissions that follow the NWFCC 2012 theme of “Progressive Fish Culture in the Northwest.” However, all topics relevant to fish culture in the Northwest will be considered. Session topics will be:

- 1) Progressive Fish Culture
- 2) Hatchery Operations/ New Technology
- 3) Fish Health and Nutrition
- 4) Fish Culture Equipment and Innovations
- 5) Miscellaneous Topics in Fish Culture

Guidelines for submissions:

- 1) **TITLE** – Center and bold title in Times New Roman, 12 point font, at top of abstract
- 2) **PRESENTER** – list authors and designate presenter by a “ * “ , employer or affiliation, mailing address, city, state, zip, phone and email should be included, superscript numbers can be used for authors with alternate contact information
- 3) **POSTER** or **ORAL** – Please indicate presentation type before the abstract
- 4) **ABSTRACT** – (250 words, 500 max) – Use Times New Roman Font / Size 12 in MS Word
- 5) **TABLES** – A table or figure can be included with the abstract, but the entire “expanded” abstract (Abstract plus table or Figure) is restricted to one page total
- 6) **SUBMISSIONS** – Please submit by August 31, 2012 to Nathan_wiese@fws.gov or Jim_bowker@fws.gov
- 7) **EXAMPLE** – Please see following page for an example abstract
- 8) **PRESENTATIONS** – All presentations must be in Power Point, 15 minutes for presentation and 5 minutes for questions.
- 9) **POSTERS** – Posters need to fit in a 4x4 space, poster boards will be provided.

Along with great presentations, attendees will be able to visit with vendors and exhibitors during breaks and socials, to ensure great information and products are taken back to each operation.




Figure 1. Exponential knowledge gained by attending NWFFC 2012.
