Notes:

1. Jim Tisdale (USFWS, Route 1, Box 142, Brooksville, MS, 39739; 601-323-5548) is the contact for the private lands program for Region IV. If a private group like Weyerhaeuser develop the language for a Partners Agreement, it needs to be reviewed by Tisdale before being signed.

2. Cooperators providing wolves access to land under a Partners Agreement during any fiscal year are paid at the end of that fiscal year. To receive payment they must provide ARNWR a receipt that includes the following wording:

a. This invoice is submitted as per executed agreement which requires the Fish and Wildlife Service to pay ___ \$ ___ for allowing red wolves to inhabit ___ and for allowing Fish and Wildlife personnel access to ___ during the period 1 October 19?? through 30 September 19??.

For example: This invoice is submitted as per executed agreement which requires the Fish and Wildlife Service to pay Hoodoo Corporation \$1,200 for allowing red wolves to inhabit Hoodie Farms and for allowing Fish and Wildlife personnel access to Hoodie Farm during the period 1 October 1993 through 30 September 1994.

3. No later than 1 September project personnel should contact cooperator and indicate that an invoice must be received before payment can be authorized. Alligator River NWR budget official should have the invoice by 15 September of each year.
