Background:

This position is a standard PD (SPD) that is used Service-wide.

Series and Title Determination:

As the Assistant Regional Director for Fisheries, the incumbent has Region-wide managerial, leadership, and advocacy responsibility for programs, policies, and issues in the Fishery program. The position is best described by the 480 series, Fish and Wildlife Administration, which covers positions that lead scientific or professional work involved in administering, directing, or exercising technical control over program, regulatory activities, projects and/or operations of fishery resources, fish and wildlife resources, and/or their habitats. The position will be titled Fish and Wildlife Administrator. As the position is a managerial position, it will be classified using the General Schedule Supervisory Guide, reference b.

Program Scope and Effect	The incumbent directs and leads the Regional Fishery Program and Operations. Programs directly impact State and local agencies, private industry, non-profit organizations, and private land owners. The scope and effect of the program best match level 1-3.	1-3	550

Personal Contacts	The incumbent is in frequent contact with high level officials in the Service and DOI; public interest groups; news media; State, Tribal, or local government agencies; and professional organizations. The type of contacts best matches level 4A-3.	4A-3	75
	The incumbent explains and defends scientific decisions; negotiates across programmatic and regional lines with FWS; negotiates the cooperation of private industry, other Federal agencies, and Congressional staff members to accomplish FWS goals and objectives; and actively participates in high level conferences and meets. At level 4B-4, the incumbent faces intense opposition or resistance where the other party is fearful, skeptical, or uncooperative. The incumbent often faces this type of opposition when working with the public and private industry, particularly when the other party feels that their rights are being impinged upon or they are not sure how the proposal will benefit them.	4B-4	125
