FALL PHOTO FESTIVAL

- Contest submittal runs from September 10 – November 2, 2012
- The selection of the winning photo will be held at the Friends of WNWR at the annual meeting held November 10, 2012 by the attending members.
- Winners will be notified no later than November 30, 2012
- The winners of the contest will receive:
 - First Prize - \$50; photo included on homepage of the Friends website with recognition; photo to appear on a Willapa National Wildlife Refuge publication with recognition.
 - Second and Third Prize photographers will receive \$30 and \$20 respectively and a free T-shirt.
 - Free press and publicity.
- Rules:
 - A \$10 entry fee covers entries for all three categories; but no more than 3 photos/entrant.
 - There will be three categories that the photographers can enter:
 1. Wildlife (birds, mammals, fish, amphibians, reptiles, insects, etc.) that is native to the refuge.
 2. Flora (trees, scrubs, wildflowers, aquatics, grasses, sedges, rushes, ferns, mosses, and lichen) that is native to the refuge.
 3. Scenic views within Willapa Refuge (Refuge HQ including Salmon Art Trail and Cutthroat Climb Trail, Riekkola Unit, Teal Slough, Leadbetter Point).
 - Entrants can submit photographs for all three categories, but the total number of entries is limited to 1 per category.
 - Submittal must be postmarked by November 2, 2012 and can be mailed to the Refuge office-3888 State Route 101, Ilwaco, WA 98624-9707 or dropped off at the "Picture Attic" – 711 Pacific Avenue North, Long Beach and must include:
 - 8"X 10" photo (Friends will matt the photo).
 - Check for \$10 for the entry fee made payable to FWNWR.
 - Contact information including: Name, mailing address, phone number(s) and email address.
- Selection process
 - The photos will be matted and displayed at the Friends of Willapa NWR annual membership meeting on November 10, 2012.
 - Membership will vote to determine the winning photo for each category.
