Howdy Steve - sorry for the delayed response, still getting back into the swing of things after being gone for a few days.

Anyway, the key for any wolf mgmt plan is going to be the ability of the mgmt agency to regulate take. Most agencies do this by clearly defining when take may occur or, when recovery has been achieved, classifying them as a game animal or other similar designation so that rules and regulations guide the taking of the species, whether that be through sport hunting or conflict or defense of life/property; very similar to what you have been working through with the SAG and very similar to how many other species are managed. I think the plans provided demonstrated adequate regulatory processes although the only one that I know of that was officially Service-approved was the Wind River plan (with the possibility of the Blackfeet plan since it was completed prior to delisting).

Hope that helps a bit, but would be happy to chat more about it anytime if needed.
