Thanks for getting back in touch. I will be working on analyzing those mouse numbers this month. When do you need them by?

I heard from Pete that you might be presenting some of your owl data to an owl group. What is the occasion and when? I will be working to help get you some answers to common questions, but

it might be best if someone that represents the mouse project were there to answer questions from the public about the proposed project, and its possible affects on owls and other species. Not really fair to have you taking on those types of hard questions when you don't have much of the background on the alternatives that might be proposed.

We are working on the EIS with the FWS and PRBO right now, and will likely have a document ready for public review by spring.

If you could send Pete or I the information about your meeting and audience, we can possibly help you out.
