Your organization's application for Federal financial assistance titled "Protect, Conserve and Monitor the Farallon Islands' Ecosystem" submitted to the U.S. Fish and Wildlife Service's (USFWS) CFDA Program 15.608 is approved. This award is made under the authority of the Fish and Wildlife Act of 1956, as amended, 16 U.S.C. 742a-742j. For a complete list of this program's authorizing legislation, go to <https://www.cfda.gov/> and search by the CFDA Program number. This award is made based on USFWS approval of your organization's proposal (SF424 Application) signed on 05/14/2014, hereby incorporated by reference into this award. Funds under this award are to be used to provide stewardship with Point Reyes Bird Observatory doing business as Point Blue Conservation Science (Point Blue) at the U.S. Fish and Wildlife Service (Service), Farallon National Wildlife Refuge (Refuge). The objective is to protect, conserve and monitor the Farallon Islands ecosystem including but not limited to birds, mammals, salamanders, insects, other wildlife and plants. This project will benefit the Refuge by maintain facilities on the Farrallon Islands and by collecting data to help guide management actions and promote public awareness:

The Recipient Will:

- Furnish the necessary personnel, equipment and supplies and otherwise perform all things necessary for or incident to assisting the Service on the Farallon National Wildlife Refuge (Refuge) with: managing and promoting public awareness of the Refuge; monitoring of seabirds, marine mammals, and other wildlife and plants; providing routine sea going transportation for staff and supplies.
- Providing protective services for Refuge lands and wildlife to the maximum extent possible.

- Operating, maintaining and improving the facilities including conducting inspections and preventative maintenance in accordance with procedures outlined in the Farallon Operations Handbook and Monthly Maintenance Checklist.
- Furnish monthly phone line/internet communications services that interface with Service-provided communications hardware.
- Provide information and expert opinion to the Service for refuge management purposes.
- Assist the Service with development or review of reports, proposals, plans, environmental compliance documents, or other documents pertaining to the Refuge that are within the scope of Point Blue's expertise.
- Participate in the Refuge Safety Committee.
- Meet periodically with Service personnel to assess progress and to promote exchange of information to assure coordination of this cooperative effort.

The Service Will:

- Take all responsibility for managing the Refuge.
- Provide biologists and maintenance personnel, on an as available basis, necessary to maintain Service facilities and equipment.
- Conduct habitat management activities.
- Conduct biological activities, and other administrative duties.
- Meet periodically with Point Blue to provide technical assistance and review progress related to the cooperative effort.
- Provide basic equipment, including major kitchen appliances, washer, water supply and filter system, and materials and equipment necessary to maintain the Service facilities on Southeast Farallon Island.
- Provide an electrical system necessary for power to the Service facilities, water supply pump, workshop and boat hoist, including all parts, overhauls, oil, fuel, wires, circuit breakers required to maintain the electrical system.
- Provide 2 boats with outboard motors (one each for North and East Landing) for use in accomplishing tasks specified in this Agreement.
- Provide radio and satellite communication system hardware to ensure adequate communications for health and safety of personnel on the island.

Project Period:

The project period of this award is April 1, 2014 through September 30, 2019. This is the period of Federal sponsorship. Point Blue may invoice for expenses dating back to April 1, 2014. This project will be funded incrementally over time based on availability of funds. The Service will provide funds (Base Funds) to Point Blue annually, or more often if necessary, to accomplish and enhance the public benefits incorporated in this agreement based on the following formula as funds allow: 1) the equivalent annual salary (at the calendar year 2014 local geographic federal base pay) of one GS-7 and one GS-11, Step 1; plus 2) a fixed 20% benefits adjustment; plus 3) a per diem allowance (at \$20/day per person camp rate) for two people for the entire year. Additional funding for other specific projects may be provided as they become available. For each increment of funding, Point Blue will need to submit the following federal forms: 1) SF424 Application for Federal Assistance; and 2) SF424A Budget (Non-construction programs). Also, additional funds for specific projects will require separate scopes of work.

The funding period for the first segment of this project is April 1, 2014 through March 31, 2015. The total amount of USFWS funding available for the first segment of this project is \$173,855.00. Only allowable costs resulting from obligations incurred during this funding period and any authorized pre-award costs that are approved may be charged to this award.

The USFWS may revise this award over time to add new funding for each subsequent project segment. Each project segment will be assigned a specific funding period, during which only allowable costs resulting from obligations incurred during the specified funding period may be charged to this award. All obligations incurred during a funding period must be liquidated within 90 days of the funding period end date. You must submit a written request to the USFWS Project Officer before the end of the stated period if you need more time to liquidate all obligations.

The USFWS's obligation to provide incremental funding up to the total anticipated award amount is contingent on: 1) satisfactory Recipient performance and 2) the availability of funds. Federal Share/Match Requirements: Point Blue will provide in-kind services valued at a 2:1 match. In-kind services include, but are not limited to, additional staff/interns needed for data collection, coordinating transportation and logistics for the island, and activities that result in other public benefits as outlined above. The total annual cost of the project to Point Blue is approximately \$500,000.

For pinnipeds, average and peak monthly adult and pup counts will be included. The monthly reports will also contain information on staffing, visitors, dates and numbers of visitors to the Wilderness Area, weather, bird, marine mammal, salamander or cricket activity of interest, habitat restoration activities, violations, sightseeing boat activity, maintenance, fuel and water usage, and other noteworthy wildlife or human occurrences on or around the Refuge. The April report will contain an estimate of water collection.
- Annual Seabird Report (due December 15 each year) that includes the following information for all seabird breeding species: 1) breeding population estimate (including maps of survey results and correction factor calculations); 2) breeding success (described as average number of chicks/breeding pair, combining first and second attempts; include sample size); 3) other components of breeding success (i.e., average clutch size, brood size, hatching success and fledgling success); 4) dates of last chicks fledged; 5) numbers of chicks and adults banded; and 6) interpretation of results and management recommendations. For species where estimates of population size or breeding size monitoring is problematic (i.e., ash and Leach's storm-petrels, double-crested cormorant, Cassin's and rhinoceros auklets, and tufted puffin), other information such as numbers banded, capture/recapture data, box occupancy rates, index plot data, number of active sites, etc. will be included as appropriate. For common murre and Brandt's cormorants, the report will provide information from each sample plot.
- Annual Pinniped Report (includes April to March, due the following May 1 each year). This report will include northern elephant seals, northern fur seals, Steller sea lions, California sea

lions, harbor seals. The elephant seal section will include breeding activity and provide data on total breeding population size and breeding success. Numbers of breeding females, pups and weaners produced, and pup mortality will be reported for SEFI colonies, and as access/observation conditions allow, for West End colonies. Methods, interpretation of results, management information, and information on West End monitoring (e.g. dates and number of trips and number of animals disturbed) will also be included. Sections for all other species will include breeding activity, timing of breeding, graph of annual population cycle (average and variance), peak number of pups, and discussion of trends relative to historical data.

- Annual Ecosystem Report (due August 15 each year). This report will include but is not limited to landbirds (migrants and owls), white sharks (predation events), salamanders (population index), insects (including cricket population index), and summaries on other wildlife and plant monitoring.

All reports and other deliverables must be sent to the USFWS Project Officer.

Project Plan and Budget Amendments:

Recipients are permitted to re-budget within the approved direct cost budget to meet unanticipated requirements and may make limited program changes to the approved project. However, certain types of post-award changes in budgets and projects shall require the *prior written approval* of the USFWS Project Officer. 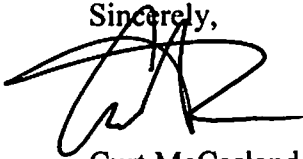

Product A: Power analysis to detect changes in the abundance of juvenile and adult Farallon arboreal salamanders under cover boards

Objectives:

- To determine whether current monitoring of juvenile and adult salamanders provides sufficient statistical power to demonstrate change in abundance in 5 year increments over 20 years.
- To determine if the addition of small cover boards increased our power to detect changes in juvenile salamander abundance, to inform assessments in the event of mouse eradication.
- To determine the number of years required to detect an ecologically significant change in the abundance of juvenile and adult salamanders.

Background/Justification for study:

A study on the Farallon arboreal salamander (*Aneides lugubris farallonensis*) population was initiated in 2006 to determine seasonal activity, relative abundance, population status and trends and reproductive behavior. This information was important to establish a baseline to measure potential impacts of the planned mouse eradication. Results from a power analysis conducted in 2012 using data from 2006-2011 indicated that pre-eradication data provided sufficient statistical power to detect a 40% increase in juvenile salamanders within two to three years of data collection post-eradication. Information drawn from the original study is unfortunately limited to a small portion of Southeast Farallon Island and was not representative of the island-wide population size or density, and relied on data that may be skewed towards larger individuals.

In order to gain a more complete understanding of abundance and distribution of this species, a series of extensive island-wide surveys were conducted from the Fall of 2012 to the Spring of 2015. In addition, this new study included “small” cover boards paired with the “large” cover boards in an attempt to increase our ability to detect juvenile salamanders. To meet our objectives listed above we plan on combining data collected in the initial study with that of the new study (8 years of data) and conduct a power analysis to examine differences in detection prior vs post implementation of the “small” boards. Based on simple analysis of the current data we believe that the small boards are increasing our detection of juvenile salamanders and that performing another power analysis with our current data will provide more robust results to aid in management decisions related to the proposed mouse eradication project.

In addition to conducting power analyses on juvenile Farallon arboreal salamanders, we will employ similar methods for adult salamander population. With that information, we can determine whether the current study design is adequate to detect changes in salamander population over the long-term. This measure is important because it reflects more on the overall salamander population, including long-term production and survivorship.

- To predict salamander habitat based on robust statistical models including the main physical and biological drivers of salamander abundance.
- To estimate salamander abundance in high use areas based on predicted densities.

Background/Justification for study:

A study on the Farallon arboreal salamander (*Aneides lugubris farallonensis*) population was initiated in 2006 to determine seasonal activity, relative abundance, population status and trends and reproductive behavior. This information was important to establish a baseline to measure potential impacts of the planned mouse eradication. Information drawn from this study is unfortunately limited to a small portion of Southeast Farallon Island and was not representative of the island-wide population size or density. In order to gain a more complete understanding of abundance and distribution of this species, a series of extensive island-wide surveys were conducted from the Fall of 2012 to the Spring of 2015. Current methods of reporting salamander distribution involve reporting the number of salamanders by area based on the cover boards sampled in particular transects around the island. We will use a combination of GIS and rapid assessments to characterize potential physical drivers including slope, aspect, substrate and distance to cover areas. In addition, we have detailed information on biological drivers including type and abundance of vegetation in areas where salamanders have been sampled. Vegetation may be a form of cover for salamanders and the prey they depend on. We will use this information to identify physical and biological drivers of distribution and abundance of salamanders on the Southeast Farallon Island. Specifically, we plan to use Generalized Linear Modeling (GLM), particularly Negative Binomial Regression, to develop predictive models of salamander counts based on the main physical and biological drivers controlling for inter-annual differences in environmental conditions that may have affected our sampling scheme. Having more insight into salamander distribution and abundances around the island will allow estimating minimum and maximum (\pm confidence interval) population sizes on Southeast Farallon Island.



Cosco Busan Auklet Box Restoration on Southeast Farallon Island
Point Blue Conservation Science

In 2014, Point Blue Conservation Science began designing and conducting trials on prototype new artificial nest structures for Cassin's and Rhinoceros Auklets. This project is being conducted to develop new nest structures for the auklets that will keep internal temperatures near natural burrow and crevice nest sites while being long lasting, cost effective, and permit for easy and low disturbance monitoring. In 2014-15, Pt. Blue biologists began investigating potential materials and building prototype nest structures while completing a study comparing air temperatures between natural nest sites, wooden artificial nest boxes (uncovered boxes), and wooden artificial nest boxes covered with shading to reduce solar penetration into the box (covered boxes). That study found that temperatures differed between the three study groups, with temperatures progressively warmer between uncovered boxes, covered boxes, and natural nest sites, respectively.

For artificial nest structure prototype development, Point Blue worked in close collaboration with Oikonos Ecosystem Knowledge, along with master ceramicist Nathan Lynch from More Lab and the California College of the Arts, to design test units using ceramic materials. After extensive research and development, we devised two prototype designs to test: a shielded ceramic nest box which approximated conventional designs, and a dome structure with a central ceramic tube and ventilation holes to help alleviate heat, along with an external ceramic dome shielding which rotates around the unit. Temperature testing and installation of concrete boxes was initiated in April 2015 and in ceramic test designs in October 2015.

Over the next year, Point Blue will assess temperature values in new prototype units, and analyze them relative to area specific controls and reference conventional nest boxes. They will evaluate prototype temperatures relative to previously established relationships. Also, they will complete a draft manuscript on our temperature logger studies and habitat evaluations.

Scope of Work
Restoration Catalyst Fund Project: Farallon NEPA
Point Blue Conservation Science

As part of its cooperative agreement with the U.S. Fish and Wildlife Service – Farallon National Wildlife Refuge (Refuge), Point Blue Conservation Science (Point Blue) has been assisting the Refuge with National Environmental Policy Act (NEPA) compliance, including preparation of an Environmental Impact Statement (EIS), for a proposed house mouse eradication project. Point Blue’s assistance has included conducting or assisting with collection of baseline data on Farallon wildlife and conducting studies related to assessing the efficacy or potential impacts of potential eradication techniques.

One of the most crucial analyses of potential impacts to the Farallons Islands concerns the effectiveness of the western gull hazing program. The USFWS received several comments on the Draft EIS about the uncertainty surrounding the potential adverse impacts of western gulls being exposed secondarily to anticoagulant rodenticide bait. To address this uncertainty, Point Blue Conservation Science, Island Conservation, and USFWS completed a hazing trial in November and December 2012 to evaluate the effectiveness of a combination of non-lethal wildlife hazing techniques including biosonics, pyrotechnics, lasers, a helicopter, reflective objects and effigies, for temporarily reducing western gull numbers at the South Farallon Islands, and therefore reducing gull exposure to rodenticide. They examined the relative effectiveness of these tools for dissuading gulls as well as the impact of these treatments on pinnipeds and other non-target bird species present on the islands. The hazing trial successfully demonstrated the feasibility of keeping gulls off the islands for an extended period of time (in this case a 12-day interval) while having relatively minor impacts on other species, namely other seabird species and pinnipeds. Hazing efforts were 98% effective at keeping gulls off the island and away from areas that would be baited during an eradication effort.

As part of the Avian Risk Assessment for South Farallon Islands that was completed as a component of the Draft EIS, the western gull risk model determined that a hazing success of 90% or higher was necessary to avoid rodenticide having a population level impact as defined by a previously completed gull population viability analysis (see Appendix F – Western Gull Risk Assessment (December 10, 2012) from the Draft EIS for additional information). Point Blue is currently in the process of completing a manuscript for publication in Journal of Wildlife Management; however, funding support is needed to complete the final manuscript and submit it for publication. There are three other key eradication-related products (described below) that are essential to the restoration planning process and require additional funds so that they can be completed.

For the Restoration Catalyst Fund project, Point Blue will complete the following baseline studies for the Farallon mouse eradication project NEPA analyses:

1. Complete a manuscript reporting on the promising findings from the western gull hazing trials on Southeast Farallon Island (due April 30, 2016);
2. Complete a manuscript on a recent burrowing owl diet study (due April 30, 2016);

3. Complete updated ashy storm-petrel population modeling (due April 30, 2016);
4. Complete the western gull population viability analysis based on potential impacts from rodenticide exposure (due April 30, 2016); and
5. Continue to assist the Refuge with the NEPA process including review of potential alternatives, preparation and review of draft versions of the final EIS.

As part of its cooperative agreement with the U.S. Fish and Wildlife Service – Farallon National Wildlife Refuge (Refuge), Point Blue Conservation Science (Point Blue) has been assisting the Refuge with National Environmental Policy Act (NEPA) compliance, including preparation of an Environmental Impact Statement (EIS) for a proposed house mouse eradication project. Point Blue's assistance has included collating and providing scientific data on Farallon Islands' natural resources from their extensive work, collating other useful information, providing technical expertise, reviewing and editing documents, conducting or assisting with collection of baseline data on Farallon wildlife, and conducting studies related to assessing the efficacy or potential impacts of potential eradication techniques.

In order for Point Blue staff to continue to provide the Service with needed assistance on the Farallon mouse eradication NEPA process, funding of \$20,000 is provided by the Service through funds provided by the National Fish and Wildlife Foundation's North Pacific Seabirds initiative. The budget includes salary for the Farallon Program Manager (about 1 month) and Marine Ecology Director (about 0.5 months) and travel (e.g., mileage) to attend meetings.
