Welcome

Ash Meadows National Wildlife Refuge is home to over 26 species of plants and animals that exist nowhere else on earth.

The refuge was established and is managed to protect threatened and endangered plants, animals and their habitats. The information in this pamphlet supports the refuge management plan.

Safety

Visitors, staff, and private landowners are always present on the refuge and will not be wearing orange safety vests. Always use caution! Do not enter private lands or restricted areas for any reason.

Firearms

Persons possessing, transporting, or carrying firearms on National Wildlife Refuge System lands must comply with all provisions of State and local law. Persons may only use (discharge) firearms in accordance with refuge regulations (50 CFR 27.42 and specific refuge regulations in 50 CFR Part 32.)

Shotguns are the only firearms permitted and must be used in regulation with state hunt program. Only non-toxic shot may be possessed by hunters in the field. All firearms must be unloaded and dismantled or cased while in vehicles. Hunters are responsible for picking up litter, including discharged shells.

Vehicles

Only registered and insured passenger vehicles are allowed on the refuge. Passenger vehicle is defined as a "motor vehicle that is designed, constructed or adapted for the principal purpose of transporting passengers," but excludes off-highway vehicles.

All off-highway vehicles (OHVs) are prohibited.

Boats

Non-motorized and electric boats are allowed **only** in Peterson Reservoir and must be thoroughly cleaned and decontaminated prior to entry. See Invasive Species section.

Hunting Regulations

Hunting regulations are designed to provide safe recreational opportunities through wise use of renewable wildlife resources. Hunting is permitted in accordance with Federal regulations governing public use on National Wildlife Refuges as set forth in Title 50 of the Code of Federal Regulations.

Hunting will be in accordance with applicable State of Nevada regulations for the current year, except where federal regulations differ to protect visitors, staff or protected species. Brochures may be obtained by mail, at the refuge headquarters, or from the refuge website.

Access

Hunters may only access the Refuge two hours before legal sunrise until two hours after legal sunset.

Invasive Species

Invasive species are a preventable problem. Help the refuge protect the endemic species living here by taking these precautions before hunting on the Refuge:

Clean visible plants, animals, and mud from boots, waders, hip boots, watercraft, push poles, decoys, decoy lines and anchors before using at the Refuge. Allow all gear to thoroughly dry before transporting to the Refuge.

Brush hunting dogs and rinse kennels with tap water before hunting. Dogs are not allowed in waterways.

Drain water from watercraft, bilge, and other watercontaining devices and allow to thoroughly dry before using.

All watercraft using Nevada waters are required to display an Aquatic Invasive Species decal. Decals can be purchased at https://www.ndow.org/get-outside/boating/aquatic-invasive-species-prevention-program/.

Use non-felt soled boots to further reduce the spread of invasive species.



Prohibited Activities

By law, recreational activities on national wildlife refuges are prohibited unless expressly permitted. The following are prohibited at Ash Meadows National Wildlife Refuge:

- Hunting in or over any springs or stream channels.
- Carcasses or offal in trash cans.
- Use or possession of alcoholic beverages while hunting.
- Predator hunting.
- Shooting from or across maintained refuge roads.
- Fires, fireworks, or smoking outside vehicles or outside designated smoking areas.
- Fishing, off highway vehicles (OHV's), horseback riding and collecting of antiquities, artifacts, plants, wildlife or other natural objects.
- Hunting within 200 yards of any public use facility.
- Overnight parking or camping.
- Dogs off leash when not hunting.
- Dogs in springs or other waterways for any reason.

Signs and Boundaries

Please respect the following signs:

No Vehicles: All Traffic prohibited

Refuge boundary: Entry permitted in accordance with refuge regulations.
