This report discusses the major activities that have occurred in the Program since the April 2011 meeting. The Program office was focused almost entirely on implementation of the 2011 high flow releases.

#### Budget Update and Process

- Due to the number and duration of the 2011 continuing resolutions, several 2011 projects could not be implemented. A list of 2012 projects to be funded with 2011 funds will be developed prior to the TMC meeting next week.
- Development of the 2012 budget has become the sole responsibility of Program managers with input from the technical staff via the work groups. This transition away from significant input from technical staff is the result of input from the TAMWG. A preliminary 2012 budget will be unveiled at the TMC meeting in Weitchpec.

#### Science and Monitoring Update

We have continued to focus on executing independent reviews of Trinity River Restoration Program scientific study plans, technical reports and program areas.

The plan is to have study plans reviewed by independent experts before funding decisions are made. As a demonstration of this, 25 independent experts reviewed Fiscal Year 2012 investigation plans. Plans will be revised based on reviewer input.

Technical reports will also be reviewed by independent experts. An internal review will occur simultaneously. Following the review period an author will respond to comments and revise their report accordingly. As an example of this parallel external / internal review process, a draft report titled "2010

Bed-material Sediment Budget Update, Trinity River, Lewiston Dam to Douglas City, California” was just evaluated by an outside expert and physical work group members. The author will now respond to comments and update the report. It is anticipated that some reports will not require external review. For instance, the draft report titled “Photographic Monitoring of Channel Rehabilitation Sites on the Trinity River, California, 2007-2010” involves a simple approach and will simply be reviewed internally. Such proposed exemptions will be announced.

- DRAFT Temporal and Spatial Distribution of Chinook Salmon Redds in the Mainstem Trinity River 2002 to 2010
- Sub-program review: Adult Salmonid Monitoring Evaluation
  - o Goal: Determine the efficacy of the current extent/scope; field methodologies and statistical analyses used in the adult salmonid assessments in meeting the information needs of the Program.
  - o Elements: Run Size and harvest (Junction City and Willow Ck Weirs and Hatchery recovery project), Harvest (Hoopa, Yurok, Lower Klamath recreational, Lower Trinity recreational), Age Composition, Redd/Carcass Survey, Coded Wire Tagging, CWT recovery/decoding, Adult fish health.
  - o Lead reviewer: Mike Bradford, Fisheries and Oceans Canada.
  - o Support: Dave Hankin, Humboldt State University.
