Hi Susan,

This email is regarding a project taking place on the Dungeness NWR in Northern WA. The Jamestown S'Klallam Tribe will be installing an Oyster growing operation on 5-acres (phase 1) and they are targeting a start date of June 1, 2021. This area is prime habitat for shorebirds, eelgrass, brant, and other waterfowl.

Long story short, they need to present a monitoring plan to the USACE and County that will determine if their activities affect birds during operations. I do not have this expertise and your work in Willapa Bay and the Oystergrowers came to mind. The Tribe may be reaching out to USGS for some guidance to see if the methods they have drafted will answer this question of disturbance.

This project is political, and a quick call with the Dungeness Refuge Project Leader and our I&M program may be beneficial to see if you would be willing to talk to them. Could we grab you for an internal meeting on April 28th after 2:00 PM, or if you can suggest someone else with your expertise (on survey design and stats), that would work too.
