QUALIFIED BAT SURVEYORS

The U.S. Fish and Wildlife Service Pennsylvania Field Office (Service) and the Pennsylvania Game Commission (PGC) carefully review the skills and experiences of individuals interested in conducting bat surveys in Pennsylvania and maintain a list of Qualified Bat Surveyors (QBS). Individuals on the QBS list are available for bat surveys in Pennsylvania on a contractual basis. Please note that any individuals handling or conducting surveys for State or federally listed bats must first obtain a permit from the PGC. Bat surveys are overseen by a QBS, who is permitted by the PGC and required to be present in the field at all times during the investigation as specified by the permit. The list does not necessarily include all individuals qualified to survey for bats, and inclusion on the list does not constitute endorsement by the Service or any other Federal or State agency. Persons not on this list, but who have documented experience in conducting scientific studies of, or successful searches for, Pennsylvania State or federally listed bats may submit their qualifications to the Service and PGC for review. Applications for the year will be accepted starting January 1. Applications must be received by March 31 for each year. Please contact the Service and PGC for additional guidance. Additions to and deletions from this list are at the sole discretion of the Service and PGC. This list is subject to revision at any time without prior notice.
