Dear Ms. Deal and Ms. Willis:

The Florida State Clearinghouse has coordinated a review of the referenced NRDA Phase II Early Restoration Plan proposal under the following authorities: Presidential Executive Order 12372; § 403.061(42), *Florida Statutes*; the Coastal Zone Management Act, 16 U.S.C. §§ 1451-1464, as amended; and the National Environmental Policy Act, 42 U.S.C. §§ 4321-4347, as amended.

The Florida Department of State (DOS), Division of Historical Resources' review of the Florida Master Site File indicates that there are numerous cultural resources located within the projects' area of potential effect. Staff states that, although some project related activities could adversely affect cultural resources, DOS is currently consulting with the Florida Department of Environmental Protection (DEP) and Florida Fish and Wildlife Conservation Commission on ways to avoid, minimize or mitigate any potential adverse effects. The DEP's Coastal Construction Control Line (CCCL) Program staff notes that the proposed installation of bird fencing stakes, new or retrofitted light poles or modified light fixtures would not require a CCCL permit. The requirement to obtain a CCCL permit would only be triggered by proposed significant physical alterations of the land seaward of the CCCL (*i.e.*, new or



Based on the information contained in the submittal, negligible project impacts and proposed environmental benefits, the state has determined that the NRDA restoration activities are consistent with the Florida Coastal Management Program (FCMP). The state's continued concurrence will be based on the activities' compliance with FCMP authorities, including federal and state monitoring of the activities to ensure their continued conformance, and the adequate resolution of any issues identified during subsequent reviews.
