Bill,

The DWH Case Management Office is continuing to move the proposed Early Restoration projects forward through the various environmental compliance consultations. First, we would like to thank you for all your efforts in the Intra-Service ESA Section 7 consultations your office conducted for the proposed projects. We are currently working on the Coastal Barrier Resources Act consistency determinations. There is one project in Alabama that will have Federal expenditures and is being evaluated by the Trustees as a potential early restoration project. The early restoration project was proposed in the draft early restoration plan that was released for public comment and review on December 6, 2013. If the Trustees select the project after consideration of public comment and a stipulated agreement is reached with BP, the early restoration project will be implemented by NOAA.

We used the Coastal Barrier Resources System mapper – Beta (http://www.fws.gov/cbra/Maps/Mapper.htm [accessed May 19, 2014]) to determine if proposed projects were located within an Otherwise Protected Area or within a System Unit. If the proposed project will occur in an Otherwise Protected Area or outside of a System Unit, no additional analysis was developed.

Swift Tract Living Shoreline, Alabama

The proposed Swift Tract Living Shoreline project will be implemented by NOAA and the State of Alabama (Figure 1). The Swift Tract Living Shoreline project will use standard living shoreline techniques including natural and artificial breakwater material to stabilize eroding shorelines. These materials will dampen wave energy to stabilize eroding shorelines, allow for sediment accretion and provide substrate for oyster and bivalve recruitment. Additionally, this project will protect freshwater marsh and forested wetlands located just inland of the shoreline. The project would provide for construction of up to 1.6 miles of breakwaters in Bon Secour Bay adjacent to the 615 acre Swift Tract parcel, which is part of the Weeks Bay National Estuarine Research Reserve (NERR) (Figure 1). Over time, the breakwaters are expected to develop into reefs that support benthic secondary productivity, including, but not limited to, bivalve mollusks, annelid worms, shrimp, and crabs. The living shoreline project will be constructed on public property in the eastern portion of Bon Secour Bay, approximately 6 miles northwest of Gulf Shores in Baldwin County, Alabama.

Consistency Analysis

The Swift Tract Living Shoreline project occurs entirely within AL-04P Coastal Barrier Resource System Unit (CBRS). We have determined that CBRA does not apply because this is an Otherwise Protected Area and the only prohibition is Federal Flood Insurance.

If there is anything else we need to capture for CBRA please let me know.
