On April 30, 2018 we received your request to extend the duration of the above referenced permit. We may extend your permit for a maximum period of five years from the original expiration date. The extension of the duration is hereby approved, and the expiration date of the permit is changed as follows:

Original Expiration Date: August 26, 2018

New Expiration Date: August 26, 2023

Please attach this letter to your permit. This letter does not change any of the permit conditions or relieve you of obtaining any necessary authorization from other state, federal or local agencies. Please call if you need further assistance.

In accordance with Section 252.363, F.S., the permitted activity will continue to be governed by the rules in effect at the time the permit was issued. However, any future request to modify the permit, except where the modification lessens the environmental impact, will be governed by the rules in effect at the time of the modification.

This extension does not:

1. Alter any other terms or conditions of the permit.
2. Affect the expiration date of any associated state-owned submerged lands lease or easement that was executed for the activities authorized in the permit. It also does not change any terms or conditions contained in the lease or easement, such as deadlines for submittal of any required lease fees.

3. Affect the water quality certification determination under Section 401, Public Law 92-500, 33 U.S.C. Section 1341 made as part of the permit.
4. Affect the coastal zone consistency concurrence determination made under Florida's Coastal Zone Management Program in Section 307 of the Coastal Zone Management Act and 15 CFR 930, Subpart D originally contained in the permit.
5. Affect the expiration date of any state, federal, or local permit, license, or authorization related to this permit, specifically including any federal permit under Section 404 of the Clean Water Act or Section 10 of the Rivers and Harbors Act of 1899.

This letter constitutes final agency action unless a person substantially affected by this action requests an administrative hearing pursuant to Section 120.57, Florida Statutes. The petition must be filed within fourteen (14) days from receipt of this letter. The petition must comply with the requirements of Florida Administrative Code Rule 28-5.201 and be filed pursuant to Rule 62-103.155(1) in the Office of General Counsel of the Department of Environmental Protection at 3900 Commonwealth Boulevard, Tallahassee, Florida 32399-3000. Petitions which are not filed in accordance with the above provisions will not be accepted by the Department. The hearing process is designed to formulate agency action. Accordingly, the Department's final action as a result of a hearing may be different from the position taken by it in this stage. Therefore, any person who may wish to contest the Department's ultimate permitting decision must petition for a hearing within the fourteen-day period described above. Failure to file a request for hearing within this time period shall constitute a waiver of any right such person may have to request a hearing under Section 120.57, Florida Statutes.
