Subject:	Request to Convert Conference Reports to Consultations Regarding Loggerhead			

The DWH Case Management Office recently completed conference reports with your office regarding eight projects (and any components within) proposed for Deepwater Horizon Phase III Early Restoration (see Table 1). These conferences each evaluated potential impacts from the proposed projects to the proposed Northwest Atlantic Ocean Loggerhead Sea Turtle Distinct Population Segment critical habitat. Your office concurred that no adverse modification or destruction of loggerhead critical habitat would occur due to the proposed projects should the proposed critical habitat become designated critical habitat.

As you are aware, critical habitat was designated on July 10, 2014. None of the proposed Early Restoration Phase III projects have been implemented at this time. Because all the consultations were completed recently and none of the project descriptions have changed except as noted in Table 1, we have concluded our previous determinations are still valid (Table 1). We request your concurrence (via signature below) thereby confirming the conference reports as informal consultations. All other information and determinations remain the same.
