The Department has evaluated your request to extend the expiration date for this permit. We may extend your permit for a maximum period of two years from the date of receipt of all governmental authorizations for this project. Your permit is hereby extended until **October 29, 2017**. Should you be unable to complete your project by that date, you should contact the Department.

Please attach this letter to your permit. This letter does not change any of the permit conditions or relieve you of obtaining any necessary authorization from other state, federal, or local agencies. Please call if you need further assistance.

This letter constitutes final agency action unless a person substantially affected by this action requests an administrative hearing pursuant to Section 120.57, Florida Statutes (F.S.). The petition must be filed within fourteen (14) days from receipt of this letter. The petition must comply with the requirements of Florida Administrative Code (F.A.C.) Rule 28-5.201 and be filed pursuant to Subsection 62-103.155(1), F.A.C., in the Office of General Counsel of the Department of Environmental Protection at 3900 Commonwealth Boulevard, Tallahassee, Florida 32399-3000. Petitions which are not filed in accordance with the above provisions will not be accepted by the Department. The hearing process is designed to formulate agency action. Accordingly, the Department's final action as a result of a hearing may be different from the position taken by it in this stage. Therefore, any person who may wish to contest the Department's ultimate permitting decision must petition for a hearing within the fourteen day period described above. Failure to file a request for hearing within this time period shall constitute a waiver of any right such person may have to request a hearing under Section 120.57, F.S.
