The Office of Coastal Management (OCM) has received the "Draft Phase IV Early Restoration Plan for the Deepwater Horizon Oil Spill," dated May 21, 2015 and submitted on behalf of the U.S. Department of the Interior (DOI), the National Oceanic and Atmospheric Administration (NOAA), the U.S. Department of Agriculture (USDA), and the U.S. Environmental Protection Agency (USEPA). Two of the proposed projects included in the plan, as currently proposed, have potential impact to Louisiana's coastal zone:
