Proposed BP Settlement Consent Decree and Deepwater Horizon Oil Spill Draft Programmatic Damage Assessment and Restoration Plan for the Gulf of Mexico

The U.S. Department of Justice (DOJ) and the Deepwater Horizon Natural Resource Damage Assessment Trustees (Trustees) invite the public to a series of meetings as they seek public comments on two documents. DOJ is asking for public comment on a proposed Consent Decree with BP. This Consent Decree sets forth a settlement between BP, the United States, and the five Gulf states resolving claims for federal civil penalties and natural resource damages related to the Deepwater Horizon oil spill.

The Trustees are seeking public comment on the Deepwater Horizon Oil Spill Draft Programmatic Damage Assessment and Restoration Plan (PDARP) and Draft Programmatic Environmental Impact Statement (PEIS). The draft plan would allocate funds for restoration from a settlement with BP for up to \$8.8 billion for natural resource injuries
