Gentlemen,

Revised plans attached in 5 drawings furnished with your request to enhance the existing Grand Isle 9 artificial reef site by installing and maintaining constructed reef materials to provide structural habitat for the purpose of enhancing fishing opportunities in the Gulf of Mexico, are approved and will be included in your plans for the work authorized by the Secretary of the Army in a permit, MVN 2009-02747 EMM, dated November 23, 2009, from the District Engineer at New Orleans, Louisiana. These plans are in addition to those of your original authorization. The permit is specifically extended to December 31, 2022.

The conditions, except the expiration date, to which the work is made subject remain in full force and effect. In addition, please provide as-builts of the completed work.

A copy of the first page of this permit approval letter must be conspicuously displayed at the project site. Also, you must keep a copy of this signed letter, with attached drawings, at the project site until the work is completed.

Permittee is aware that this office may re-evaluate its decision on this permit at any time the circumstances warrant.


If the work authorized is not completed on or before the date herein specified, this authorization, if not previously revoked or specifically further extended, will cease and become null and void.






