It includes for each Government department and agency the text of proposed appropriations language, budget schedules for each account, legislative proposals, explanations of the work to be performed and the funds needed, and proposed general provisions applicable to the appropriations of entire agencies or groups of agencies.

To the extent feasible, the data has been adjusted to provide consistency with the FY 2007 Budget and to provide comparability over time.
