## Appendix E: Oregon LSRCP Fish Hatcheries Operations and Maintenance Costs Summary

### *FY2009 Operating Budgets*

Funding for operation of the state and tribal operated hatchery facilities in the Lower Snake region and associated support costs for fish health are derived from Lower Snake River Compensation Plan (LSRCP) fishery mitigation program funds and the Northwest Power and Conservation Council, Fish and Wildlife Program, both through the Bonneville Power Administration. The four fish hatcheries (FH) are operated by the Oregon Department of Fish and Wildlife (ODFW) and their satellite acclimation and adult recapture facilities are operated by ODFW, the Nez Perce Tribe (NPT), and the Confederated Tribes of the Umatilla Indian Reservation (CTUIR).

### *Major Maintenance and Construction Costs*

The operating budget for the Oregon LSRCP facilities presented above includes cyclical maintenance but does not cover all maintenance costs. The following lists the total cost of major maintenance and construction projects for each facility for years 2004-2008. These are proposed projects to be covered with LSRCP funds and may not reflect all of the maintenance and construction costs associated with operating the facilities.
