

Timetable

January 29, 2008	A petition was filed by Friends of Animals requesting the U.S. Fish and Wildlife Service list 14 parrot species under the Endangered Species Act (ESA).
July 14, 2009	<p>The Service published a 90-day finding (74 FR 33957), in which the agency determined that the petition presented substantial scientific and commercial information to indicate that listing may be warranted for 12 of the 14 parrot species. In the Service's 90-day finding on this petition, the agency announced the initiation of a status review to list as endangered or threatened under the ESA the following 12 parrot species:</p> <ol style="list-style-type: none"> 1. Blue-headed macaw (<i>Primolius couloni</i>), 2. Crimson shining parrot (<i>Prosopeia splendens</i>), 3. Great green macaw (<i>Ara ambiguus</i>), 4. Grey-cheeked parakeet (<i>Brotogeris pyrrhoptera</i>), 5. Hyacinth macaw (<i>Anodorhynchus hyacinthinus</i>), 6. Military macaw (<i>Ara militaris</i>), 7. Philippine cockatoo (<i>Cacatua haematuropygia</i>), 8. Red-crowned parrot (<i>Amazona viridigenalis</i>), 9. Scarlet macaw (<i>Ara macao</i>), 10. White cockatoo (<i>Cacatua alba</i>), 11. Yellow-billed parrot (<i>Amazona collaria</i>), and 12. Yellow-crested cockatoo (<i>Cacatua sulphurea</i>). <p>The Service initiated the status review to determine if listing each of the 12 species is warranted, and initiated a 60-day public comment period to allow all interested parties an opportunity to provide information on the status of these 12 species of parrots. The public comment period closed on September 14, 2009.</p>
July 28, 2010	A settlement agreement was approved, in which the Service agreed to (in part) submit to the <i>Federal Register</i> by July 29, 2011, a determination whether the petitioned action is warranted, not warranted, or warranted but precluded by other listing actions for no fewer than four of the petitioned species.
August 9, 2011	The Service published status reviews for the crimson shining parrot (<i>Prosopeia splendens</i>), yellow-crested cockatoo (<i>Cacatua sulphurea</i>), white cockatoo (<i>Cacatua alba</i>), and Philippine cockatoo (<i>Cacatua haematuropygia</i>) (76 FR 49202).
October 6, 2011	The Service published a status review for the red-crowned parrot (<i>Amazona viridigenalis</i>) (76 FR 62016).
October 11, 2011	The Service published a status review for the yellow-billed parrot (<i>Amazona collaria</i>) on October 11, 2011 (76 FR 62740).
October 12, 2011	The Service published status reviews for the blue-headed macaw (<i>Primolius couloni</i>) and grey-cheeked parakeet (<i>Brotogeris pyrrhoptera</i>) (76 FR 63480).
July 6, 2012	The Service published status reviews for the great green macaw (<i>Ara ambiguus</i>) and military macaw (<i>Ara militaris</i>) (77 FR 40171), hyacinth macaw (<i>Anodorhynchus hyacinthinus</i>) (77 FR 39965) and scarlet macaw (<i>Ara macao</i>) (77 FR 40221).

January 10, 2013	The Service proposed to add the blue-throated macaw as endangered under the Endangered Species Act and opened a 60-day day public comment period (78 FR 2239).
March 12, 2013	The Service published a rule listing the yellow-billed parrot as a threatened species under the Endangered Species Act. The rule goes into effect on April 11, 2013 (78 FR 15624).
October 3, 2013	The Service published a rule listing the blue-throated macaw as an endangered species under the Endangered Species Act. The rule goes into effect on November 4, 2013 (78 FR 61208).
June 24, 2014	The Service published the final rule listing the yellow-crested cockatoo and Philippine cockatoo as endangered and the white cockatoo as threatened under the Endangered Species Act. The rule goes into effect on July 24, 2014 (79 FR 35869)
October 2, 2015	The Service published a rule listing the great green macaw and military macaw as endangered species under the Endangered Species Act. The rule goes into effect on November 2, 2015 (78 FR 15624).
