This letter is in regard to your Freedom of Information Act (FOIA) request dated December 31, 2015 for records related to:

- 1. Any and all records, including but not limited to, reports, memoranda, emails, notes, letters, documentation, correspondence and other communication pertaining to the "not warranted" listing determination by the United States Fish & Wildlife Service for the Greater Sage-grouse under the Endangered Species Act, see 80 Federal Register 59,858 (Oct. 2, 2015), or records concerning the agency's planning or other decisions made for consideration by the Service in the "not warranted" listing decision, for the period January 1, 2014 to the present.*
- 2. Any and all FOIA requests (and responses by the Federal agency- to such FOIA requests, if any) from other parties for records, including but not limited to, reports, memoranda, emails, notes, letters, documentation, correspondence and other communication pertaining to the "not warranted" listing determination by the United State Fish & Wildlife Service for the Greater Sage-grouse under the Endangered Species Act see 80 Federal Register 59,858 (Oct. 2, 2015), or records concerning the agency's planning or other decisions made for consideration by the Service in the "not warranted" listing decision, for the period January 1, 2014 to the present.*

On May 19, 2016 we sent you a partial response. In that response, we stated that additional documents that may be responsive to your request were being reviewed. Enclosed you will find a CD containing two hundred and forty-four (244) additional documents responsive to your request, which are being released to you in their entirety. As described in our letter to you dated September 8, 2016 we are continuing to review other potentially responsive records for release and anticipate providing additional partial responses to you every Tuesday until our FOIA response is complete.

You may appeal this response to the Department's FOIA/Privacy Act Appeals Officer. If you choose to appeal, the FOIA/Privacy Act Appeals Officer must receive your FOIA appeal **no later than 90 workdays** from the date of this letter. Appeals arriving or delivered after 5 p.m. Eastern Time, Monday through Friday, will be deemed received on the next workday.

**Your appeal must be made in writing.** You may submit your appeal and accompanying materials to the FOIA/Privacy Act Appeals Officer by mail, courier service, fax, or email. All communications concerning your appeal should be clearly marked with the words: "FREEDOM OF INFORMATION APPEAL." You must include an explanation of why you believe the Fish and Wildlife Service's (Service) response is in error. You must also include with your appeal copies of all correspondence between you and the Service concerning your FOIA request, including your original FOIA request and the Service's response. Failure to include with your appeal all correspondence between you and the Service will result in the Department's rejection of your appeal, unless the FOIA/Privacy Act Appeals Officer determines (in the FOIA/Privacy Act Appeals Officer's sole discretion) that good cause exists to accept the defective appeal.

Please include your name and daytime telephone number (or the name and telephone number of an appropriate contact), email address and fax number (if available) in case the FOIA/Privacy Act Appeals Officer needs additional information or clarification of your appeal.


Please note that using OGIS services does not affect the timing of filing an appeal with the Department's FOIA & Privacy Act Appeals Officer.
