

PRIVACY ACT STATEMENT

Authority: The information requested is authorized by the Migratory Bird Treaty Act (MBTA) (16 U.S.C. 703 et seq.) and Parts 13 and 21 of Title 50 of the Code of Federal Regulations.

Purpose: To collect the contact information of participating parties in the transfer or sale of migratory waterfowl and to monitor the take and disposition of migratory birds.
