

## **Draft Compatibility Determination for Hunting and Fishing on North Dakota Limited-Interest National Wildlife Refuges**

**Use:** North Dakota Limited-interest National Wildlife Refuges Hunting and Fishing Plan

**Refuge Purpose(s):**

"...as a refuge and breeding ground for migratory birds and other wildlife..."

"...for use as an inviolate sanctuary, or for any other management purpose, for migratory birds." 16 United States (U.S.) Code § 715d (Migratory Bird Conservation Act)

“shall be administered by him [Secretary of Interior] directly or in accordance with cooperative agreements...and in accordance with such rules and regulations for the conservation, maintenance, and management of wildlife, resources thereof, and its habitat thereon.”

**National Wildlife Refuge System Mission:**

The mission of the National Wildlife Refuge System (Refuge System) is to administer a national network of lands and waters for the conservation, management, and where appropriate, restoration of the fish, wildlife, and plant resources and their habitats within the U.S. for the benefit of present and future generations of Americans.

**Description of Use:**

*What is the use? Is the use a wildlife-dependent public use?*

The U.S. Fish and Wildlife Service is proposing to open 41 easement refuges to hunting of resident game species and 38 easement refuges to fishing. For specific details, see the 2020 North Dakota Limited-interest National Wildlife Refuges (NWRs) Hunting and Fishing Plan and the 2020 Environmental Assessment (EA) for Hunting and Fishing on North Dakota Limited-interest NWRs.

This is a wildlife-dependent public use.

*Where will the use be conducted?*

On privately owned and fee-title lands within the acquisition boundaries of the subject easement refuges.

*When will the use be conducted?*

During the respective North Dakota Game and Fish (NDGF) regulated hunting and fishing seasons for resident game and fish.

*How will the use be conducted?*

Hunting and fishing will be conducted according to NDGF rules and regulations for resident game species and fish as well as specific refuge rules and regulations as published in 50 Code of Federal Regulations and refuge hunting and fishing brochures. Boating will be closed on all easement refuges during the regular North Dakota waterfowl season except on Buffalo Lake, Camp Lake, Cottonwood Lake, Hiddenwood, Rose Lake, School Section Lake, and Sheyenne Lake NWRs.

*Why is this use being proposed?*

To provide the public with a high quality recreational experience on additional refuge lands in North Dakota and to increase opportunities for hunters and anglers.

**Availability of Resources:**

Resources involved in the administration and management of the use: Limited to updating signage and providing the public with information in regard to the hunts, rules, regulations, and law enforcement during the respective hunting and fishing seasons.

Special equipment, facilities, or improvements necessary to support the use: Minor. Updated refuge-specific hunting brochures and signage.

Maintenance costs: Minor and insignificant. Estimated to be \$40,000 to implment and then 5 percent of current refuge law enforcement program staff time for overseeing and implementing the hunt and fish program.

Monitoring costs: None.

Offsetting revenues: None.
