Equal Employment Opportunity Discrimination Complaints Counseling Program

All Federal employees, former employees, and applicants of the U.S. Fish and Wildlife Service, who believe they have been discriminated against on one or more of the following bases: race, color, religion, sex, national origin, age (40 and over), physical or mental disability, reprisal (for prior EEO activity participation), pregnancy, sexual orientation*, status as a parent*, and/or protected genetic information*, must discuss the matter with an EEO Counselor during pre-complaint. Contact with an EEO Official must occur within 45 calendar days from the date of the alleged discriminatory incident, or in the case of a personnel action, within 45 calendar days of the effective date of the action; or within 45 calendar days when an individual becomes aware of the alleged discriminatory action.

If resolution is not reached during the pre-complaint process, then the individual will be advised of their right to file a discrimination complaint within 15 calendar days from the date of receipt of the Notice of Final Interview. *Persons may be represented at any stage of the pre-complaint or complaint process, and may request anonymity during the pre-complaint process.*
