Public Meetings and Public Comment Periods

The Trustee Council hosts public meetings to communicate with the public about important documents, the Natural Resource Damage Assessment process, and specific projects. The Portland Harbor Community Advisory Group (CAG)

The Trustee Council provides updates to the CAG twice a year. The CAG meets on the second Wednesday of each month from 6 p.m. to 8 p.m. at the City of Portland's Water Pollution Control Lab at 6543 N. Burlington Avenue in the St. Johns neighborhood. The meetings are open to the public and are a great way to get informed about a wide range of Portland Harbor issues.
