

**M/V Selendang Ayu Oil Spill
Natural Resource Damage Assessment and Restoration**

**Trustee Resolution 2017-01:
Disbursement of Reimbursement of Past Assessment Costs**

1. *Whereas*, the United States Department of the Interior (DOI), acting through the United States Fish and Wildlife Service (USFWS), the United States Department of Commerce, acting through the National Oceanic and Atmospheric Administration (NOAA), and the State of Alaska, acting through the Departments of Environmental Conservation (ADEC), Fish and Game (ADFG), Law (ADOL), and Natural Resources (ADNR), are the six Natural Resource Trustee agencies (“Trustees”) responsible for the natural resource damage assessment and restoration (NRDAR) associated with the 2004 M/V *Selendang Ayu* oil spill that occurred along the northern shore of Unalaska Island, Alaska;

2. *Whereas*, on November 25, 2016, the Trustees submitted to the United States Coast Guard’s National Pollution Funds Center (NPFC) a request for funding to reimburse the Trustees for past assessment costs and to support the Trustees’ future efforts to complete the injury assessment and restoration planning work and to prepare a draft Restoration Plan; and


3. *Whereas*, the Trustees were awarded funding in 2017 from the NPFC in the amounts of (a) \$1,236,943.47 as reimbursement of the Trustees’ past assessment costs and (b) \$2,462,117.00 for the Trustees’ future work to complete the injury assessment and restoration planning work and to prepare a draft Restoration Plan; and these funds are to be deposited into the DOI NRDAR Fund, Account #0451, on behalf of the Trustees;

4. *NOW, THEREFORE, BE IT RESOLVED*, the Trustees request that, following receipt of the NPFC funds into the DOI NRDAR Fund, Account #0451, the DOI NRDAR Fund releases the reimbursements of past assessment costs to the individual Trustee agencies as further described below. (No release of funds to USFWS is requested at this time.)
