3. Agency Updates --

BLM --

Christine has a new job. Works with state office now. Works on transmission lines.

interns went out to do habitat assessment work north of Minersville this summer. Habitat in this area is pretty poor -- cheat grass and juniper encroachment. no signs of sage-grouse.

SRB mitigation --offsite mitigation for transmission line. will treat 850 p/j near jackrabbit lek in October/November. Focus area: Adams Well, Long Hollow, and Jackrabbit

Hamlin Valley delayed because Christine was focused on SRB for a bit. Goal is to have it out in October.

South Beaver is geared up for this fall.

Becky - fire updates - 3 wildfire in sagebrush this year. Gap (800 acres), Black Mountain (5000 acres, 3500 acres of mapped SG habitat), and Rush Lake (300 acres of mapped SG habitat; along the phone line in Adams Well area). Currently working through funding and seed issues for restoration this fall. Considering using temporary electric fences to protect reseeding.

UPD plague vaccine study is on the ground. UPD Management Areas will be filled in with action items and action steps. Translocated to Black mountains and buckskin valley, also in Parker Mountain.

Jason/Nile -

couple of lop and scatter projects in Hamlin Valley, about 1000 acres. pipeline and water development in Choke Cherry in the next month. Marked the allotment fence. BLM provided the markers, did 2.4 miles of fence using the BLM specifications. Chaining vegetation looks good and White Rock fire looks good, given the weather we've had.

Nile is retiring! September 27th is last day.

John Keeler -- Trans-west powerline display of the different deterrents that they've been developing for bird aversion

Trans-west Express will be going from Wyoming to Vegas

Nicki - Research update

Cheyenne submitted thesis, working on publications

Heather still working on thesis, but provided summary reports

New student - Erica Hansen - started today. will be working with the key players to get a plan together.

Chad - Ag Extension Update

Black Green has money to use gasification to harvest woody material. Want a plant in Cedar and Panguitch.

Noxious Weed meeting - in St. George in August usually. They are moving it to November. Will rotate around the sound in the future. About 8 hours long, get that as credit toward their licensing. This would be enough for private landowners. Planning for Hurricane in November 2013.

Randy Marshall -

Been seeing grouse west of Bullocks well. Has thick PJ there. Not really good habitat. GIP projects coming in. Sign-up period going through the end of November.

Seeding of the Baboon Fire looks terrific. Lots of forbs and grasses growing back, looks really great. BLM marked 30 miles of fences in that area. Marking all new fences (in GRSG habitat)
