Craig-

I just left you a voice mail. As we discussed previously, attached is my staff's draft write-up on livestock and horse impacts, primarily in Nevada, that we thought might be helpful to you in your chapter preparation. Others in the Service have reviewed this, and they expressed interest in getting similar livestock grazing information for other Great Basin states, including Oregon (Jeff Dillon?), Idaho (Dennis Mackey?) and Utah (Jay Martini?). As the chapter lead, do you want to make this request? Would you like help?

The specific ask for those states would be to, (1) identify the number of livestock grazing allotments that have been monitored for compliance with existing grazing standards; (2) of those monitored, how many currently meet those standards; and (3) identify whether there are any firm commitments with timelines for implementation of the actions proposed in the BLM/FS plan amendment. Items 1 and 2 were in the draft EIS for Nevada/California, and item 3 was in the Administrative Draft Proposed Plan. Hopefully their respective documents have this same information. Feel free to extract the livestock information from this write-up and share it as an example if you wish.
