Meeting Purpose and Goal: Senior members of NRCS' Sage-Grouse Initiative and FWS' sage-grouse conservation team will meet to discuss and advance two key aspects of the bureaus' ongoing partnership to conserve greater sage-grouse and working landscapes across the species' range: incorporating SGI spatial data into FWS' Endangered Species Act status review; and, Candidate Conservation Agreements with Assurances.

The goal of the meeting will be to identify and conclusively address any outstanding questions or issues associated with these topics and move forward together to deliver effective, durable conservation on private lands in sage-grouse range.

Meeting logistics and participation: We will meet at FWS' Mountain-Prairie Regional Office (Ecological Services conference room, 6<sup>th</sup> floor). We will have VTC capability for remote participants. We will take a 45 minute (off-site) lunch break to maximize meeting time.
