Hope you are doing well. Please see attached a draft agenda for our meeting next week. Please review and let me know if you have revisions. Please note I included a placeholder for your roster. A few notes on the meeting:

- We have a conference room that accommodates ~20 folks. We'll have VTC capability and a laptop projector. I anticipate 7 or so FWS folks in person and roughly ½ again that number via VTC and/or phone. In terms of our actual roster, you can expect the folks copied here, plus our other ARDs-ES (or their representatives); and key members of our technical team.
