SGTF meeting, 1/20-21/15: Follow up items

- Post status review .ppt to FWS GrSG website and advise WGA when URL is active; WGA will distro URL to SGTF (EA, Kales)
- Confirm current registration status of ACK-55/Battalion Pro w/IR-4 and advise Sarah Greenberger

and WGA/SGTF (Kales)

- Meet by phone with DAS Lyons (~1200 MST, 1/27) to discuss SO 3336 next steps and FWS role (RD, ARDs, other FWS GrSG team members). Likely topics include:
 - How to identify and use relevant information in the SO/implementation in our status review process
 - Implementation of FIAT
- In light of Director's reference to GrSG section of recent Audubon climate change report (<http://climate.audubon.org/birds/saggro/greater-sage-grouse>), ensure our a robust approach for addressing climate change in our status review (RD, ARD, other FWS GrSG team members)
- Convene a meeting with NRCS/SGI to identify and reconcile remaining differences between our GrSG CCAA program and SGI (ES)
 - Revise FWS communications products per above (ES, EA)
- Explore solutions to SGI data landowner privacy issues, (Kales, ES, NWRS/PFW, MB/JVs)
 - FWS will Investigate Farm Bill section 1619 provisions and past approaches for potential workaround and recommend a path forward for the Director
- Ensure ongoing coordination among and between FWS private lands practitioners (PFW and ES collaboration bios) and SGI/SWAT (ES, NWRS/PFW)
