I did add a question for Shauna in a comment bubble : Question for Shauna.....if the impact is 20 years, and it takes 20 years to grow the habitat, won't the required duration be 40 years (20 years for habitat to come on-line + 20 years of actual benefit now that the habitat is functional & available?

The answer to that question may flavor how we summarize a question under duration. Hope my additions are useful, and if I've mis-characterized something, please adjust accordingly.
