As requested, please find attached *ARD Mitigation Review Package* containing the following information:

- 1) Draft charter for the Mitigation Review Team (MRT);
- 2) Goals and objectives assigned to the MRT;
- 3) List of pressing policy questions for leadership consideration;
- 4) Proposed process to guide Service approval of mitigation programs, including pre-listing mitigation agreements; and
- 5) Process to review mandatory criteria for Mitigation Programs seeking pre-listing mitigation and Service approval, including a list of near-term criteria issues that will require additional capacity to resolve.

We have also attached an initial, working draft of Standard Operating Procedures that we propose to flesh out as the Review processes become standardized.

We do anticipate that additional policy questions will emerge as we run through the review process. We specifically request clarification on the MRT's role in future "direct" local agreements (like Barrick and Sweetwater Conservation Bank) and the anticipated timeframe the MRT will operate.
