First a huge THANK YOU to you and your teams for helping with the batch download of HabITS data into the GRSG Conservation Efforts Database (CED). We had a couple of programming and QA/QC hiccups, but we're finally finished. Couple of notes for you all:

1. I encourage you and your team to go to the CED and check out the interactive map (CED registration not required.) I have run several checks of projects in R1 to confirm that the "buffer and wobble" process worked as intended, and that the true locations are masked appropriately. However, if you have any concerns with how any of the PFW projects are being displayed, please let me know and we can get them changed.

Go to: <https://conservationefforts.org/grsgmap/>  
Click on the "Search/Query Tools" on the far left side of the screen  
Under Implementing Party, select US Fish and Wildlife Service  
Under "Office", select Partners for Fish and Wildlife Program  
Zoom in and out and check out the efforts in your area.

Note that NRCS will not be providing data in the CED, but are providing us SGI information through other venues.

2. We had to change our plan for naming the efforts in the CED because so many HabITS project names had landowner/ranch names embedded within them. The CED effort names are now a combo of the HabITS project number, the accomplishment number, and the phrase "Private Lands". Good reminder of why we have the policy to not use landowner names in project titles.
