Hi All,

We will be making some revisions to the Restoration Partnership. Please review the attached proposed layout and compare it to the current website. Below is a summary of the changes that are currently proposed.

- The “HOME” section of the menu bar will be reduced to a simple icon at the left of the menu bar and will only include the “Privacy Policy,” “Copyright Information,” and Endorsement Disclaimer” subpages.
- “ABOUT US” will now include the “Contact Us,” and “FAQs” subpages (which are currently under the “HOME” section).
- “RESTORATION” will now be named “WHAT IS RESTORATION?” It will still include the “Restoration vs. Remediation” and “Restoration Techniques” subpages.
- “THE PLAN” is a new section (being pulled from the current “Restoration” section) and will include the “EIS” (which will be a new page), “NEPA” (which is a renaming of the old “Restoration Planning” page), and “Comment” (which will duplicate the “Shape the Plan” subpage and only be available during the Public Commenting phase) subpages.
- “Human Services” is a renaming of the current “Activities & Uses” page.
- “MEDIA” is a new section and includes the “Press Releases,” “Publications,” “Video,” “Photo Gallery,” “Maps,” and “Other Resources” subpages.

There will also be some text edits being done by the Restoration Team as well. Please let me know what you think about these changes and whether you have any other revisions you think might be important to the website by 12/24/14.
