Subject: GRSG: Sage-grouse biologist and Project Leaders meeting invite.

Good Afternoon-

As you are aware Congress has passed a spending bill that includes specific provisions for greater sage-grouse. The spending bill does not affect our ability to develop, implement, and analyze conservation efforts to support the species. Nor does it relieve us of our obligation to determine by Sept. 30, 2015 whether the species still warrants protection under the ESA. In fact, the expectation of Congress and the Interior Department is that we will continue to push forward with these efforts with the same urgency as before.

We're now bringing on additional staff who've been working on planning or conservation to help us draft report chapters, review information, and prepare for the analysis and decision workshops this spring.

In the past, the Field Management Team (FMT) has come together in person to discuss sage-grouse work (largely plan revisions). It's been almost a years since we held our last FMT meeting and we're shifting our focus now from planning to the status review.

For all of the above reasons, we want to hold an all-status-review team meeting in January, 2015. If you are receiving this invitation you have a direct role in the status review and we want you to attend. If there are difficulties please work with your respective Regional ARD regarding participation and coverage.

Goals:

- Discuss spring analysis workshops and solicit feedback from project leaders
- Improve communication within and between teams by providing face-to-face contact for employees working with team members in other offices and regions
- Provide a solid foundation so all parties understand their roles and the roles of others in this process
- Address concerns and needs of team members
