Cedar Creek Anticline. You will notice that Bell Creek is outside core area. Cedar Creek Anticline is obviously in core area. Some of Elk Basin is in core area. Keep in mind that Elk Basin is mostly in Wyoming but some of the field is in Montana.

Cedar Creek Anticline and Elk Basin should be listed as Special Management Core Areas. Bell Creek should not be listed as a Special Management Core Area since it is not in a core area.
