electronically available on the WGFD Website within the timeframe prescribed above.

- Proposed changes to core area boundaries under consideration by Local Working Groups, will be made publically available no less than 45 days prior to their consideration. Notice shall be made to all persons making timely requests for advanced notice of consideration of changes to core area boundaries by LWGs. This information will also be made electronically available on the WGFD Website within the timeframe prescribed above.
- Recommendations for core area boundary adjustments forwarded by the LWGs to the SGIT will be made publically available no less than 45 days prior to their consideration by the SGIT. Notice shall be made to all persons making timely requests for advanced notice of consideration of changes to the core area boundaries by the SGIT. This information will also be made electronically available on the WGFD Website within the timeframe prescribed above.
