Chincoteague National Wildlife **Refuge** includes more than 14,000 acres of beach, dunes, marsh, and maritime forest. We have been designated as a Globally Important Bird Area and are one of National Audubon Society's top 10 birding hotspots. Migratory birds, the legendary Chincoteague ponies, and picturesque landscapes and a family friendly beach likewise attracts approximiately 1.4 million visits annually! As the fifth most popular shorebird refuge east of the Rocky Mountains, it receives the third highest visitation in the National Wildlife Refuge System.

Our high operational tempo offers numerous chances for interns to become acquainted with visitor services and a wide variety of refuge operations and management activities. As part of a Complex, some of these activities may be carried out at Chincoteague, Wallops Island, Eastern Shore of Virginia, and Fisherman Island National Wildlife Refuges.



Visitor Services Internship: 12 weeks (May 16–August 5, 2022)

Three full time interns are needed to assist with connecting people to nature by providing high quality customer service in a variety of outlets and providing the public with safe, accessible, and high quality wildlifedependent recreational opportunities, along with maintained facilities at Chincoteague National Wildlife Refuge, Virginia.

Primary responsibilities may include but are not limited to: providing high quality customer service at the Visitor Center, conducting informal talks atop the historic Assateague Lighthouse, social media engagement, temporary exhibit/sign design, and light vehicle and grounds maintenance.

Additional responsibilities may include but are not limited to: habitat management, facilities maintenance, special event planning, and interagency partnering.

Work involves frequent indoor and outdoor activities requiring some physical exertion such as walking over wet, rough, and uneven terrain; bending, crouching, stooping, reaching, lifting, or similar activities which may occur on weekends and some holidays and evenings.

Desired background of candidates include:

- Experience speaking infront of groups (including children and school groups)
- Knowledge of animal and plant identification
- Willingness to work in an outdoor setting that may involve extreme temperatures and exposure to biting insects.





General requirements:

- U.S. citizen, national or lawful permanent resident.
- Recent college graduate or current student in Resource Interpretation, Communication, Education, Environmental Science, Natural Resources Management, or related field is preferred. All majors are encouraged to apply.
- Must be able to work well independently and with others on a wide variety of tasks.
- Must have good oral communication and writing skills.
- Must have a willingness to work on weekends and some evenings.
